## **RESOLUTION NO. 11 – 104**

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA APPROVING A TRANSFER OF FUNDS IN THE AMOUNT OF \$60,000.00 FROM THE CITY OF DORAL POLICE DEPARTMENT'S COMMUNICATIONS & FREIGHT ACCOUNT TO ITS REPAIRS AND MAINTENANCE ACCOUNT TO COVER THE CHARGES OF THE SUNGARD PUBLIC SECTOR MAINTENANCE AGREEMENT FOR THE REMAINDER OF FY 2010-2011; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral Police Department currently has a software maintenance agreement with Sungard Public Sector, Inc. (Sungard) and has received charges from Sungard for the remainder of Fiscal Year 2010-2011; and
