A RESOLUTION OF THE MAYOR AND THECITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING THE OUTCOME OF INVITATION TO BID #2022-17 ALLOWING FOR THE PURCHASE OF CIVILIAN UNIFORM ITEMS CITYWIDE FROM D&D 1523 LLC DBA PERMA-TEX; THE PLAYERS CONNECTION OF FLORIDA LLC; AND GLOBAL TRADING INC WHICH HAVE BEEN IDENTIFIED AS THE LOWEST, RESPONSIVE AND RESPONSIBLE FIRMS FOR EACH GROUP RESPECTIVELY; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, ITB No. 2022-17 was issued on May 11th, 2022, and advertised on the City's Website, Vendor Registry, DemandStar. Seven (7) people were in attendance representing six (6) firms at the mandatory pre-bid meeting that was held on May 24th, 2022. Five (5) submittals were received and opened on June 23rd, 2022, with all five (5) firms meeting the minimum required criteria set forth in the ITB; and

WHEREAS, the initial contract resultant from this solicitation shall prevail for a three (3) year period from the contract's initial effective date. Prior to, or upon completion, of that initial term, the City shall have the option to renew the contract for an additional two (2) years periods for a total of three (5) years. Award will be made on a group-by-group basis to the two (2) lowest priced responsive, responsible bidders. It is the City's intent to award both a primary and secondary firm for each group; and

WHEREAS, upon completion of Procurement's staff's review, D&D 1523 LLC dba Perma-tex, The Players Connection of Florida LLC, Global Trading Inc. were deemed the lowest responsive, responsible bidder by each group respectively.

WHEREAS, each department has allocated funds for the purchase of uniform items on an as needed basis from multiple funding sources and accounts; and

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

Section 1. Recitals. The foregoing recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

Section 2. Authorization. The City Council hereby authorizes the City Manager to proceed with purchases from D&D 1523 LLC dba Perma-tex, The Players Connection of Florida LLC, and Global Trading Inc, based on the outcome of the procurement for ITB No. 2022-17 for the Purchase of Uniforms Citywide.

Section 3. Implementation. The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the provisions of this Resolution.

Section 4. Effective Date. This Resolution shall become effective immediately upon adoption.
