## **RESOLUTION NO. 14-82**

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING AN INCREASE OF \$40,700.00 TO THE EXISTING PURCHASE ORDER FOR LOU'S POLICE DISTRIBUTORS FOR THE PURCHASE OF UNIFORMS AND EQUIPMENT FOR NEW HIRES AS WELL AS TO REPLENISH AND REPLACE UNSERVICEABLE UNIFORMS AND EQUIPMENT FOR OUR CURRENT SWORN PERSONNEL, FOR A TOTAL PURCHASE ORDER AMOUNT NOT TO EXCEED THE AMOUNT OF \$90,700.00; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the increase in personnel on account of new hires in the Police Department has created a shortage of uniforms, equipment, and other supplies for the Police Department; and

WHEREAS, certain other equipment and uniforms currently in use have exceeded their life span and need to be replaced; and

WHEREAS, in order to meet the Department's personnel and service needs, additional uniforms, equipment, and other supplies must be purchased, necessitating an increase to the current purchase order with Lou's Police Distributors (P.O. # Order #20140279); and

**WHEREAS**, the Mayor and City Council find it necessary that the Police be properly equipped to protect community.

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL
OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

**Section 1.** Recitals. The foregoing recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

Section 2. Increase in Purchase Order Approved. The increase to Purchase Order #20140279 by \$40,700.00, for a total purchase order amount not to exceed \$90,700.00, for the purchase of uniforms and equipment for new hires as well as to replenish and replace unserviceable uniforms and equipment for our current sworn personnel is hereby approved.

<u>Section 3.</u> <u>Implementation.</u> The City Manager is hereby authorized to execute the corresponding purchase order and related documentation, to spend allocated funds, and to take such other action as is necessary for the implementation of purpose of this Resolution.

<u>Section 4.</u> <u>Effective Date.</u> This Resolution shall become effective immediately upon its adoption.
