## **RESOLUTION No. 15-112**

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AWARDING RFP# 2015-07 FOR STAGE, SOUND, AND LIGHTING FOR CITY EVENTS TO TOURFX; AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT FOR THE PROVISION OF STAGE, SOUND, AND LIGHTING SERVICES FOR CITY EVENTS FOR A PERIOD OF TWO (2) YEARS WITH THE OPTION TO RENEW FOR TWO (2) ADDITIONAL ONE (1) YEAR PERIODS FOR A POSSIBLE TOTAL OF FOUR (4) YEARS, IN AN AMOUNT NOT TO EXCEED \$50,000.00 PER FISCAL YEAR; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral (the "City"), by and through its Parks & Recreation Department, organizes several events throughout the year for residents, which include 4<sup>th</sup> of July, Eggstravaganza, Holiday Lights & Ice, Camping Under the Stars, Veterans Parade, and Holiday Tree Lighting; and

WHEREAS, on April 28<sup>th</sup>, 2015, the City issues RFP# 2015-07 for Stage, Sound, and Lighting Services for City events (the "RFP"); and

**WHEREAS**, in response to the RFP, two (2) submittals were received and opened by the May 15<sup>th</sup>, 2015 deadline; and

WHEREAS, upon evaluation of the submitted proposals, Staff has recommended that the City Council award the RFP to TourFX and to authorize the City Manager to negotiate and enter into an agreement with TourFX for the provision of providing stage, sound, and lighting services for City events for a period of two (2) years with the option to renew for two (2) additional one (1) year periods for a possible total of four (4) years in an amount not to exceed \$50,000.00 per fiscal year.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS: **Section 1.** Recitals. The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

**Section 2. Award.** The RFP for Stage, Sound, and Lighting for City Events is hereby awarded to TourFX.

Section 3. Authorization to Procure Services. The City Manager is hereby authorized to enter into an agreement with TourFX, subject to approval by the City Attorney as to form and legal sufficiency, for the provision of stage, sound, and lighting services for City events for a period of two (2) years with the option to renew for two (2) additional one (1) year periods for a possible total of four (4) years in an amount not to exceed \$50,000.00 per fiscal year, and on such terms and condition as may be appropriate to protect and further the interests of the City for this matter. This Authorization does not create or confer any rights to TourFX.

**Section 4. Implementation.** The City Manager and the City Attorney are hereby authorized to take such action as may be necessary to implement the provisions of this Resolution.

<u>Section 5.</u> <u>Effective Date.</u> This resolution shall take effect immediately upon adoption.
