The City of Doral authorizes the firm of F.R. Aleman and Associates, Inc. to provide professional design services for the development of three conceptual renderings for aesthetic bus shelters that will be located along Doral Boulevard and adhere to the Doral Boulevard Beautification Master Plan. The work should be performed in accordance with the contract provisions contained in the Continuing Professional Services Final Agreement between F.R. Aleman and Associates, Inc. and the City of Doral dated February 26, 2018, and the attached Proposal dated January 2, 2019 and submitted by your firm for the above referenced project.

SCOPE OF SERVICES AND SCHEDULE:

The scope of the project will be as described in the attached proposal from F.R. Aleman and Associates, Inc. for the Preliminary design and concept of aesthetic bus shelters along Doral Boulevard. The scope of work will include the development of three conceptual alternatives, 3D renderings, and presentation to Council. The performance of services associated with this Work Order will be executed on a time and material basis not to exceed the amount of \$14,943.00.

You are required by the Continuing Service Agreement to begin work subsequent to the execution of this Work Order, or as directed otherwise. If you fail to begin work subsequent to the execution of this Work Order, the City of Doral will be entitled to disqualify the Proposal, and revoke the award.

This Work Order incorporates the terms and conditions set forth in the Continuing Services Agreement dated February 26, 2018 between the parties as though fully set forth herein. In the event that any terms or conditions of this Work Order conflict with the Continuing Services Agreement, the provisions of this specific Work Order shall prevail and apply.

Work Order is not binding until the City of Doral agrees and approves this Work Order.
