A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA RATIFYING THE ADOPT-A-STREET PROGRAM LITTER REMOVAL AGREEMENT WITH THE LAMBDA TAU CHAPTER OF PHI BETA SIGMA FRATERNITY, INC. FOR THE PROVISION OF LITTER-REMOVAL SERVICES ALONG N.W. 114TH AVENUE FROM N.W. 41ST STREET TO N.W. 34TH STREET; AND N.W. 34TH STREET FROM N.W. 112TH AVENUE TO N.W. 117TH AVENUE; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Staff respectfully requests that the City Council ratify the Adopt-A-Street Program Litter Removal Agreement with the Lambda Tau Chapter of Phi Beta Sigma Fraternity, Inc. for the provision of litter removal activities along N.W. 114th Avenue from N.W. 41st Street to N.W. 34th Street; and N.W. 34th Street from N.W. 112th Avenue to N.W. 117th Avenue.
