

**RESOLUTION NO. 12-85**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA WAIVING THE COMPETITIVE BIDDING PROCEDURES PURSUANT TO SECTION 2-321 OF THE CITY CODE FINDING IT TO BE IN THE BEST INTEREST OF THE CITY TO DO SO; AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN AGREEMENT WITH TELVUE CORPORATION FOR THE PROVISION OF ACCESS CHANNEL SERVICE AND SUPPORT FOR THE DORAL TV CHANNEL IN AN AMOUNT NOT TO EXCEED \$24,000.00; AND PROVIDING FOR AN EFFECTIVE DATE (IT)**

**WHEREAS**, since 2007, the City of Doral has contracted with Telvue Corporation (Telvue) for access channel support and service for the City's TV Channel; and

**WHEREAS**, the move to the new Government Center building requires a corresponding move of the Telvue services as well as an upgrade of the system to HD; and

**WHEREAS**, Staff respectfully requests that the City Council waive the competitive bidding procedures pursuant to Section 2-321 of the City Code finding it to be in the best interest of the City to do so and authorize the City Manager to negotiate and enter into an agreement with Telvue for the provision of access channel service and support for the Doral TV Channel in an amount not exceed \$24,000.00.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:**

**Section 1.** The City Council of the City of Doral hereby waives the competitive bidding procedures pursuant to Section 2-321 of the City Code finding it to be in the best interest of the City to do so, and authorizes the City Manager to negotiate and enter into an agreement with Telvue for the provision of access channel service and support for the Doral TV Channel in an amount not exceed \$24,000.00.

**Section 2.** This Resolution shall become effective immediately upon adoption.

The foregoing Resolution was offered by Councilmember Cabrera who moved its adoption. The motion was seconded by Councilmember Boria and upon being put to a vote, the vote was as follows:


