# **Judge Stephanie Manis Recalled With Admiration**



Fulton County Senior Judge Stephanie Manis' husband noted that their "remarkable partnership" began when they met at a Gainesville Women for Equal Rights meeting.

A cold, light rain had just started to fall and the cavernous, ornate sanctuary of The Temple on Peachtree Street was at capacity as hundreds of mourners, including a who's who of Georgia's legal community, gathered for a memorial service in honor Fulton County Senior Judge Stephanie Manis, who died Dec. 17 at age 76.

Appropriately for those familiar with the sharp-witted, yet good-natured jurist, many of the recollections recounted by those who spoke were laced with humor and poignancy.

Wiping aside tears, Manis' husband, Dr. Robert Manis, noted that his wife had passed away only four hours after their 49th anniversary, the culmination of a "remarkable partnership" that began when the two met in Florida at a Gainesville Women for Equal Rights meeting. They went on to travel the world and raise three daughters, even as Stephanie pursued a successful career as a government lawyer and judge.

He cited his wife's devotion to the law, recalling an incident when she was pulled over for a traffic violation. When the officer realized who she was, he declined to write her a ticket.

Judge Manis would have none of it. "You have to," she said.

"I'm not going to."

"I'm going to report you if you don't," said Manis. The two were at an impasse until the officer had a "terrific idea."

'Do you marry people?" he asked. When she said she did, the officer asked 'Would you marry me?'

She said she would, and the whole subject of the conversation changed," said Manis, as the two proceeded to plan the wedding.

Lisa Vayle said her mother taught her and sisters Tamara Percival and Valerie Egan that the "language of love" can be found in service to others, while Egan remembered a mentor and role model, and the "grace and dignity she showed facing death.'

Manis had undergone surgery for cancer not too long before her death and had suffered a stroke afterward. When she returned home from the hospital, she did not speak for several weeks, but she rallied and, in a conversation with Egan, said she "wanted everybody to know she opposed the death penalty.'

Egan said her mother also issued a reminder that she had not missed a day of work being sick until now."

U.S. District Judge Mark Cohen first met Manis when he took a job at the state Law Department, where Manis served from 1979 until her appointment to the bench in 1995.

Cohen began his comments by reciting an Abraham Lincoln quote: "Die when I may, I want it said of me by those who knew me best, that I always plucked a thistle and planted a flower where I thought a flower would grow."

You're looking at one of the many flowers that was planted by Stephanie Manis," said Cohen, recalling her role as mentor and confidante when he was a young assistant attorney general who followed Manis up the legal ladder, moving ultimately, albeit many years after Manis was first seated on the bench, to a judgeship.

Manis, he said, "taught me how to write like a lawyer, and she taught me how to argue a case.'


'She was a brilliant attorney, more prepared to go to court than anyone I've ever seen," said Cohen. "She could have made a lot more money in private practice, but administering justice was more important to her than any financial rewards.

Even after taking senior status in 2007, Cohen said, Manis never hesitated to take on the toughest criminal case and was presiding over one when she first felt the discomfort that started her final journey.

Robert and Stephanie Manis loved traveling and adventure, he said, noting that they had gone dog sledding at Yellowstone National Park only last year.

"Don't think for one minute that Stephanie didn't live a whole and satisfying life," said Cohen, and lives on in the souls of her husband, daughters and grandchildren. And in that of Cohen himself, who as a "26-year-old kid got under her secure wing.
