

RESOLUTION No. 11 – 53

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA AUTHORIZING THE CITY MANAGER TO EXTEND THE EXISTING AGREEMENT WITH GEOSOFT/TSO MOBILE FOR THE PROVISION OF SAFETY AND SECURITY SYSTEMS FOR THREE (3) ADDITIONAL CITY OF DORAL TROLLEYS IN THE AMOUNT OF \$21,667.50 AND AN ADDITIONAL MONTHLY MAINTENANCE FEE OF \$1,265.88; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in March 2010, the City Council approved the installation of safety and security improvements for two (2) trolleys; and

WHEREAS, since its inception with one (1) vehicle, the Doral Trolley System has expanded its fleet to three (3) vehicles and planning to expand to five (5) within fiscal year 2010-2011; and

WHEREAS, Staff respectfully requests that the City Council authorize the City Manager to extend the existing agreement with GeoSoft / TSO Mobile for the provision of safety and security systems for three (3) additional City of Doral trolleys in the amount of \$21,667.50 and an additional monthly maintenance fee of \$1,265.88.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. The aforementioned recitals are true and correct.

Section 2. The City Council hereby authorizes the City Manager to extend the existing agreement with GeoSoft / TSO Mobile for the provision of safety and security systems for three (3) additional City of Doral trolleys in the amount of \$21,667.50 and an additional monthly maintenance fee of \$1,265.88.

Section 3. This Resolution shall take effect immediately upon adoption.


