

Microsoft to Pay Infringement Suit Tab for Its AI Customers



Microsoft says it doesn't want uncertainties surrounding patent infringement law for generative artificial intelligence to scare away customers from its Copilot tool.

In a bid to prevent copyrightinfringement risks from slowing adoption of its generative AI tool, Microsoft on Thursday said it would defend any commercial customers from infringement lawsuits, including covering the costs of settlements or judgments.

The move comes amid a chorus of complaints from artists, authors, publishers and others that companies' AI language models are being trained on their creative works without their knowledge or consent.

Those objections have spurred a barrage of lawsuits, with the outcome of many uncertain, given that the legal landscape surrounding generative AI is not yet fully formed.

'This move opens up the market," Ilanah Fhima, professor of intellectual property law at University College London, told The Financial Times. She said the pledge "makes that software more usable as it removes one of the obstacles for businesses if they know that they have that reassurance"

Microsoft said its commitment applies to paying customers using its generative AI assistant Copilot, which launched in March and can be used throughout the company's suite of products to automate such tasks as writing a report to creating a slideshow. It's also integrated into GitHub Copilot, which automates the writing of computer code.

"As customers ask whether they can use Microsoft's Copilot services and the output they generate without worrying about copyright claims, we are providing a straightforward answer: yes, you can, and if you are challenged on copyright grounds, we will assume responsibility for the potential legal risks involved," Microsoft President Brad Smith and Chief Legal Officer Hossein Nowbar said in a blog post.

The pair said the company is sensitive to the concerns of creatives and believes it, rather than customers, should bear the cost of addressing them.

"We believe the world needs AI to advance the spread of knowledge and help solve major societal challenges. Yet it is critical for authors to retain control of their rights under copyright law and earn a healthy return on their creations. And we should ensure that the content needed to train and ground AI models is not locked up in the hands of one or a few companies in ways that would stifle competition and innovation."

Smith and Nowbar noted that Microsoft has built "guardrails"-filters and other technologies-into Copilot to help respect authors' copyrights. They said the company's pledge only applies to customers using those guardrails.

Microsoft is the second AI developer to commit to make users whole if they're sued for copyright infringement. The first was Adobe, which in June said it would indemnify users of its Firefly generative AI tool, which launched in March and converts text into images.

Nell Watson, a prominent AI researcher and ethics scientist, praised the Redmond, Washington-based company's move, telling TheStreet.com, This is an important move by Microsoft towards professionalizing the large language model space, and should hopefully put some fears to rest."

It's unclear what Microsoft's pledge will cost the tech giant, which generated \$168 billion in revenue and \$61 billion in profit last year.

Fhima, the university professor, told The Financial Times the tab is unlikely to be overwhelming. "There is a public interest in there being technological development, and strict rights of copyright aren't always enforced," she said. "The risk that Microsoft is taking may well be a calculated risk.'


