A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING AN OUTDOOR EVENT PERMIT FOR EL VENEZOLANO NEWSPAPER TO HOST THE "VENEZUELAN INDEPENDENCE DAY FESTIVAL" EVENT AT JC BERMUDEZ PARK LOCATED AT 3000 NW 87TH AVENUE, ON SUNDAY, JULY 6TH, 2014, FROM 7:00 AM TO 11:00 PM ON THE CONDITIONS PROVIDED HEREIN; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, EI Venezolano Newspaper (the "Applicant") submitted a permit application seeking approval from the City of Doral (the "City") for an Outdoor Event Permit (the "Application") to host the "Venezuelan Independence Day Festival" event on Sunday, July 6th, 2014 from 7:00 am to 11:00 pm at JC Bermudez Park located at 3000 NW 87th Avenue (the "Event"); and

WHEREAS, Staff evaluated the Application for the Event and recommended approval based on the conditions provided below; and

WHEREAS, the Mayor and Council desire to approve the Event Application based on the conditions provided herein.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> Recitals. The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

<u>Section 2.</u> Approval. The Outdoor Event Permit for the "Venezuelan Independence Day Festival" Event is hereby approved, with the ability to sell beer and wine during the Event, subject to the following conditions:

1. Complete submission of Outdoor Event Permit Application that includes, without limitation, a hold harmless letter and detailed event site plan, providing for such

- elements as, without limitation, location of tents, stage, portable toilets, light towers, generators, and parking area(s);
- Compliance with the City of Doral Police agreement to establish off-duty police officers at least one (1) week prior to the event;
- 3. Provision of set-up and break-down plan (with dates and times), parking plan (with designated parking areas);
- All necessary rental, clean-up, staff fees, and conditions pursuant to the fee schedule, must be furnished to the Parks and Recreation Department at least one (1) week prior to the event;
- Construction plans for tents and any outdoor structural facility must be submitted to and approved by the Building Department at least two (2) weeks prior to the event;
- 6. Certificate of Liability naming the City additionally insured must be submitted at least one (1) week prior to the event;
- **Section 3.** Implementation. The City Manager is hereby authorized to take such action as may be necessary to implement the provisions of this Resolution.
- Section 4. Effective Date. This Resolution shall take effect immediately upon adoption.

The foregoing resolution was offered by Councilmember Ruiz who moved its adoption. The motion was seconded by Councilmember Rodriguez Aguilera and upon being put to a vote, the vote was as follows:
