

**RESOLUTION No. 08 – 103**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA WAIVING THE REQUEST FOR PROPOSALS PROCESS AND AUTHORIZING THE CITY MANAGER TO ADOPT THE PUBLICLY BID CONTRACT BETWEEN BROWARD COUNTY, FLORIDA AND ATLANTIC BUS SALES FOR THE PROVISION OF A MIDSIZE BUS IN AN AMOUNT NOT TO EXCEED \$75,000.00; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the City of Doral has identified various departmental and programming transportation needs; and

**WHEREAS**, the Parks and Recreation Department in FY 08-09 budgeted funds for the purchase of a midsize bus to serve as transportation for Silver Club activities, field trips, city facility tours and other department and City needs as identified; and

**WHEREAS**, consistent with Section 12-10 of the City of Doral purchasing Ordinance, Staff respectfully requests that Council authorize the City Manager to adopt the publicly bid contract between Broward County, Florida and Atlantic Bus Sales for the provision of a 25 foot, ADA accessible, midsize bus in an amount not to exceed \$75,000.00.

**NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:**

**Section 1.** The City Council of the City of Doral, Florida hereby authorizes the City Manager to adopt the publicly bid contract between Broward County, Florida and Atlantic Bus Sales for the provision of a 25 foot, ADA accessible, midsize bus in an amount not to exceed \$75,000.00.

**Section 2.** This Resolution shall take effect immediately upon adoption.

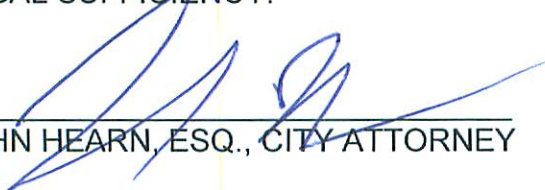
