

**RESOLUTION 05-27**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA AUTHORIZING THE APPOINTMENT OF RICHARD COKER, ESQUIRE OF COKER & FEINER AS SPECIAL COUNSEL TO REPRESENT THE CITY IN MATTERS INVOLVING COMPREHENSIVE DEVELOPMENT MASTER PLAN AMENDMENTS FOR SECTION 8 IN THE CITY OF DORAL AND RELATED MATTERS; PROVIDING FOR RECORDATION; PROVIDING AN EFFECTIVE DATE**

**WHEREAS**, Comprehensive Development Master Plan Amendments have been filed through the County on property located in Section 8 of the City of Doral; and

**WHEREAS**, the Comprehensive Development Master Plan Amendments have not been sent to the City of Doral Council for public hearing and review and have not been provided to City staff for a formal review; and

**WHEREAS**, in order to protect the City's interest, the City Council has determined it to be in the best interest of the City to retain Richard Coker as special counsel to represent the City's interest, along with staff, on these Comprehensive Development Master Plan Amendments and related matters;

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA THAT:**

**Section I.** The foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a part of this Resolution upon adoption hereof.

**Section 2.** The City Council of the City of Doral hereby authorizes the appointment of Richard Coker, Esquire of Coker & Feiner as special counsel to represent the City in matters involving Comprehensive Development Master Plan Amendments for Section 8 in the City of Doral and related matters. Mr. Coker's hourly billable rate will be \$225.00 per hour.

**Section 4.** This resolution shall become effective upon its passage and adoption by the City Council.


