

RESOLUTION NO.14-15

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN AGREEMENT WITH WOLFBERG, ALVAREZ & PARTNERS, INC., FOR THE PROVISION OF ARCHITECTURAL AND ENGINEERING SERVICES FOR THE POLICE FACILITY EXPANSION IN AN AMOUNT NOT TO EXCEED \$310,460; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in response to RFQ #2013-17 titled "Architectural and Engineering Services and Related Disciplines for Police Facility Expansion," the City of Doral received and opened eleven (11) submittals by the August 15, 2013 deadline; and

WHEREAS, upon careful review of the submittals, staff respectfully requested that the City Council authorize the City Manager to negotiate and enter into an agreement with the first top ranked firm, Wolfberg, Alvarez & Partners, Inc., for the provision of architectural and engineering services for the Police Facility Expansion, per Resolution No. 13-117; and

WHEREAS, if the negotiations failed with the top ranked firm, then negotiate a professional services agreement with the next highest ranked firms successively until an agreement was reached for subsequent submittal to the City Council for review and approval; and

WHEREAS, the City Manager and staff negotiated a professional services agreement with Wolfberg, Alvarez & Partners, Inc, first top ranked firm, in an amount not to exceed of \$310,460; and

WHEREAS, staff respectfully requests that the City Council authorize the City Manager to enter into a professional services agreement with Wolfberg, Alvarez & Partners, Inc. for the provision of architectural and engineering services for the Police Facility Expansion in an amount not to exceed \$310,460; and

WHEREAS, funding for this agreement is available in Account No. 001.6005500.621.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

Section 1. The City Council of the City of Doral hereby authorizes the City Manager to negotiate and enter into an agreement with Wolfberg, Alvarez & Partners, Inc. for the provision of architectural and engineering services for the police facility expansion in an amount not to exceed \$310,460.

Section 2. This Resolution shall take effect immediately upon adoption.
