

**RESOLUTION No. 17-35**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE CITY MANAGER TO PARTNER WITH THE MIAMI FOUNDATION TO PROVIDE SPACE FOR THE “PUBLIC SPACE CHALLENGE” WORKSHOP HOSTED BY THE URBAN IMPACT LAB AND ASSIST WITH MARKETING EFFORTS FOR THE WORKSHOP THAT WILL BE HELD ON TUESDAY, MARCH 21, 2017; AND PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the Miami Foundation (the “Foundation”) hosts an annual event, called the “Public Space Challenge” (the “Challenge”) that helps connect public spaces to the community;

**WHEREAS**, this year, the Challenge will run from March 7, 2017- April 5, 2017, and, as part of the Challenge, the Urban Impact Lab hosts a series of creative community workshops to talk about the importance of public spaces, break down the submission process, and work through potential ideas;

**WHEREAS**, the Foundation has reached out to the City of Doral (the “City”) to partner with the CITY for the 2017 Challenge to provide the space for the Challenge workshop and assist with the marketing efforts;

**WHEREAS**, the Foundation and Urban Impact Lab will be responsible for providing all materials and refreshments for the workshop; and

**WHEREAS**, staff has recommended that the Mayor and City Council authorize the City Manager to partner with the Foundation to provide the space for the workshop that would take place on Tuesday, March 21, 2017 and assist with marketing efforts.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL  
OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

**Section 2. Approval.** The partnership between the City of Doral and The Miami Foundation for the hosting of Public Space Challenge Workshops is hereby approved.

**Section 3. Authorization to Procure Services.** The City Manager is hereby authorized to coordinate with The Miami Foundation and provide appropriate meeting space within City Hall for the workshop that will be held on Tuesday, March 21, 2017.

**Section 4. Implementation.** The City Manager, City Clerk and the City Attorney are hereby authorized to take such action as may be necessary to implement the provisions of this Resolution.

**Section 5. Effective Date.** This resolution shall take effect immediately upon adoption.
