

RESOLUTION No. 16-148

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, PURSUANT TO SECTION 2-322 OF THE CITY CODE OF ORDINANCES, APPROVING THE PURCHASE OF THREE (3) UTILITY VEHICLES FOR THE PARKS AND RECREATION DEPARTMENT IN AN AMOUNT NOT TO EXCEED \$35,902.45 THROUGH THE STATE OF FLORIDA CONTRACT WITH WESCO TURF, INC., WHICH WAS COMPETITIVELY PROCURED; AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN AGREEMENT WITH WESCO TURF, INC. AND TO EXPEND BUDGETED FUNDS IN FURTHERANCE HEREOF; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral Parks and Recreation Department has budgeted funds for the purchase of three (3) utility vehicles in order to replace one (1) current Toro Workman at Doral Central Park and place two (2) vehicles, a Toro Workman and Toro Sand Pro, at the City's new Doral Legacy Park for operational uses; and

WHEREAS, Wesco Turf, Inc. and the State of Florida established an agreement for the sale of utility vehicles, which was competitively entered into a manner similar to that set forth in Chapter 2, Article V, of the City Code; and

WHEREAS, pursuant to Sec. 2-322 of the City Code, Staff has recommended that the City Council authorize the City Manager to negotiate and enter into an agreement with Wesco Turf, Inc. for the purchase of three (3) utility vehicles for the use of the Parks & Recreation Department in an amount not to exceed \$35,902.45; and

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

Section 2. Approval of Services. Pursuant to section 2-322 of the City Code of Ordinances, the purchase of three (3) utility vehicles shall not exceed \$35,902.45, through State of Florida Contract No. 21100000-15-1 with Wesco Turf, Inc., attached hereto as Exhibit "A", incorporated herein and made a part hereof by this reference, which was competitively procured in a manner similar to that set forth in Chapter 2, Article V, of the City Code; and

Section 3. Authorization to Procure Services. The City Manager is hereby authorized to negotiate and with Wesco Turf, Inc. for the purchase of three (3) utility vehicles.


Section 4. Implementation. The City Manager and the City Attorney are hereby authorized to take such action as may be necessary to implement the provisions of this Resolution.
