## RESOLUTION No. 09 - 114

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA AUTHORIZING THE CITY MANAGER TO NEGOTIATE AN AGREEMENT WITH A&P CONSULTING TRANSPORTATION ENGINEERS FOR THE **PROVISION** OF CANAL **STABILIZATION PROGRAM** MANAGEMENT; AUTHORIZING THE CITY MANAGER TO NEGOTIATE AN AGREEMENT WITH URS CORPORATION SOUTHERN AS THE SECOND HIGHEST RANKED BIDDER IN THE **EVENT** THAT AN **AGREEMENT CANNOT** SUCCESSFULLY NEGOTIATED WITH A&P CONSULTING TRANSPORTATION ENGINEERS; AND PROVIDING FOR AN **EFFECTIVE DATE** 

WHEREAS, on August 31<sup>st</sup>, 2009 the City of Doral received eight (8) proposals in response to RFQ #2009-12 titled "Canal Stabilization Program Management" by the 11:00 a.m. deadline; and

WHEREAS, Staff respectfully requests that the City Council authorize the City Manager to negotiate an agreement with A&P Consulting Transportation Engineers (A&P) for the provision of canal stabilization program management; and

WHEREAS, Staff further respectfully requests that the City Council authorize the City manager to negotiate an agreement with URS Corporation Southern (URS) as the second highest ranked bidder in the event that an agreement cannot be successfully negotiated with A&P.

NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

<u>Section 1.</u> The City Council of the City of Doral hereby authorizes the City Manager to negotiate an agreement with A&P for the provision of canal stabilization program management.

<u>Section 2.</u> The City Council further authorizes the City Manager to negotiate an agreement with URS Corporation Southern (URS) as the second highest ranked bidder in the event that an agreement cannot be successfully negotiated with A&P.

Section 3. This Resolution shall take effect immediately upon adoption.
