## **RESOLUTION NO. 13-40**

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA WAIVING THE COMPETITIVE BIDDING PROCESS, PURSUANT TO SEC. 2-321 OF THE CITY OF DORAL CITY CODE, AND AUTHORIZING THE FINANCE DEPARTMENT, DIVISION OF PROCUREMENT, TO PURCHASE FROM GALLOWAY OFFICE SUPPLIES FOR CITY-WIDE PURCHASES IN AN AMOUNT NOT TO EXCEED \$30,000.00 FOR FISCAL YEAR 2013; AND PROVIDING FOR AN EFFECTIVE DATE

**WHEREAS**, the City of Doral has streamlined the purchases of all general office supply items such as, printing paper, pens, pencils, tablets, staples, etc., by purchasing in bulk, holding inventory, and providing City Departments with supplies as needed; and

WHEREAS, for fiscal year 2013 the City has used \$15,000.00 City-wide for purchases from Galloway; and

**WHEREAS**, the City would like to continue purchasing from Galloway as one of the office supply vendors in an amount not to exceed \$30,000.00; and

WHEREAS, pursuant to Sec. 2-321 of the City Code, Staff respectfully requests that the City Council waive the competitive bidding process and authorize the Finance Department, Division of Procurement, to purchase from Galloway Office Supplies for Citywide purchases in an amount not to exceed \$30,000.00 for Fiscal Year 2013.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

**Section 1.** The City Council hereby waives the competitive bidding process and authorizes the Finance Department, Division of Procurement, to purchase from Galloway Office Supplies for City-wide purchases in an amount not to exceed \$30,000.00 for Fiscal Year 2013.

**Section 2**. This Resolution shall take effect immediately upon adoption.
