A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING THE FINAL PLAT FOR DORAL MEDICAL PLAZA, GENERALLY LOCATED NORTH OF NW 41 STREET, BETWEEN 109 AND 112 AVENUES, CITY OF DORAL, FLORIDA; PROVIDING FOR RECORDATION; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Holland and Knight, PA, on behalf of East Florida DMC, Inc. (the "Applicant") is requesting final plat approval for "Doral Medical Plaza", as depicted in Exhibit "A", the property is located north of NW 41 Street, between NW 109 Avenue and NW 112 Avenue, City of Doral, Florida, 33178, as legally described in Exhibit "B"; and

WHEREAS, this application has been reviewed for compliance with the City of Doral Code and Chapter 28 of the Miami-Dade County Code by the City Professional Surveyor and Mapper and has been found to be consistent; and

WHEREAS, on April 25, 2018, the City Council held a hearing and received testimony and evidence related to the Application from the Applicant and other persons and found that the proposed final plat meets all applicable regulations and is consistent with the Comprehensive Plan; and

WHEREAS, after careful review and deliberation, staff has determined that this application has complied with the Code.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

Section 2. Approval. The City Council of the City of Doral hereby approves the final plat for "Doral Medical Plaza", located north of NW 41 Street, between NW 109 Avenue and NW 112 Avenue, City of Doral, Florida, 33178, subject to the following conditions:

- 1. All Permanent Reference Monuments have to be in place prior to the final plat recordation.
- 2. All Permanent Control Points and Lot corners have to be in place or bonded prior to the final plat recordation.

Section 3. Recordation. This Resolution shall be recorded in the Public Records of Miami-Dade County, Florida, with the Applicant to pay the costs thereof.

<u>Section 4.</u> <u>Implementation.</u> The City Manager, City Attorney, and City Clerk are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.

Section 5. Effective Date. This Resolution shall take effect immediately upon adoption.


