

RESOLUTION No. 18-10

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, ADOPTING THE “TITLE VI NONDISCRIMINATION POLICY AND PLAN FOR SUB-RECIPIENTS” AS REQUIRED BY THE FLORIDA DEPARTMENT OF TRANSPORTATION LOCAL AGENCY PROGRAM DATED JANUARY 2018; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral (the “City”), through Florida Department of Transportation (“FDOT”), is in the process of acquiring Local Agency Program (“LAP”) Re-Certification; and

WHEREAS, FDOT is the steward of federal funding and is responsible for oversight of funded projects on behalf of the Federal Highway Administration; and

WHEREAS, LAP certification is a requirement for requesting funding by the FDOT for the development, design, and construction of transportation facilities; and

WHEREAS, in order to meet the requirements of the recertification process, the City must obtain approval from the City Council and implement a Citywide Title VI/Non-discriminatory plan which complies with all federal regulations; and

WHEREAS, the Public Works Department has recommended that the City Council adopt the “Title VI/Nondiscrimination Policy and Plan for Sub-Recipients” as required by the Florida Department of Transportation’s Local Agency Program.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

Section 2. Approval. The “Title VI/Nondiscrimination Policy and Plan for Sub-Recipients” dated January 2018 is hereby approved and adopted, in order to comply with FDOT’s LAP recertification process.

Section 3. Implementation. The City Manager, the City Clerk and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and the provisions of this Resolution.

Section 4. Effective Date. This Resolution shall take effect immediately upon adoption.
