

**RESOLUTION No.17-73**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING THE CO-DESIGNATION OF NW 52 STREET FROM NW 97 AVENUE TO NW 107 AVENUE AS “MAX SALVADOR WAY”; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the City of Doral (the “City”) adopted Ordinance 2008-15, codified as Article II of Chapter 38 in the City Code of Ordinances (the “Code”), established a policy for the naming, re-naming or co-designating of City streets; and

**WHEREAS**, the City received an application for the co-designation of NW 52 Street between NW 97 Avenue and NW 107<sup>th</sup> Avenue as “Max Salvador Way”; and

**WHEREAS**, the City’s Public Works Department has evaluated the application and found that it satisfies the criteria of Sections 38-61 and 38-62 of the City Code, including, without limitation, that Mr. Max Salvador made significant contributions to the community by furthering the incorporation of the City and the City’s good name and image; and

**WHEREAS**, the application is being sponsored by Mayor Juan Carlos Bermudez and Councilwoman Christi Fraga; and

**WHEREAS**, City Staff has recommended that the City Council approve the co-designation of NW 52 Street between NW 97 Avenue and NW 107<sup>th</sup> Avenue as “Max Salvador Way”; and

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

**Section 2.** **Approval.** The application for the co-designation of NW 52 Street between NW 97 Avenue and NW 107 Avenue as “Max Salvador Way”, a copy of the application which is attached hereto as Exhibit “A”, is hereby approved.

**Section 3.** **Implementation.** The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and the provisions of this Resolution.

**Section 4.** **Effective Date.** This Resolution shall take effect immediately upon adoption.
