

**RESOLUTION No. 16-74**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE APPLICATION TO THE EDWARD BYRNE JUSTICE ASSISTANCE GRANT (JAG) PROGRAM IN THE AMOUNT OF \$10,000.00 (REIMBURSABLE) AND EXPEND FUNDS FROM THE LETF-JUSTICE ACCOUNT IN AN AMOUNT NOT TO EXCEED \$14,500.00 FOR A TOTAL OF \$24,500.00, FOR THE PURCHASE OF MANAGEMENT SOFTWARE FROM IA PRO AND BLUE TEAM (SOLE-SOURCE VENDOR) FOR THE INTERNAL AFFAIRS UNIT; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the City of Doral Police Department has been awarded \$10,000.00 from the Edward Byrne Justice Assistance Grant (JAG) Program as a reimbursable grant and expend funds from the Department's Law Enforcement Trust Fund (LETF) Justice Funds in an amount not to exceed \$14,500.00 for a total not to exceed \$24,500.00 which will be used to purchase the IA Pro and Blue Team software as they are a sole source vendor; and

**WHEREAS**, Staff has recommended that the Mayor and City Council authorize the application to the JAG Program for grant funds in the amount of \$10,000.00 as a reimbursable grant and expend funds from the LETF- Justice Funds in an amount of \$14,500 for a total not to exceed \$24,500.00 to purchase a management software for Internal Affairs to have a paperless process, monitor complaints and incidents which may indicate patterns of employee misconduct and behavior.

**NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

**Section 2. Approval.** The City Manager is hereby authorizes the application to the JAG Program for grant funds account 001.60005.500642 in the amount of \$10,000.00 reimbursable grant and expend funds from LETF-Justice Funds account 105.60005.500640 in the amount of \$14,500.00 for a total not to exceed \$24,500.00 to purchase the IA Pro and Blue Team software as they are a sole source vendor.

**Section 3. Implementation.** The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.

**Section 4. Effective Date.** This Resolution shall become effective immediately upon its adoption.
