

## CITY OF DORAL EMERGENCY ORDER No. 2020-35 Extension of Emergency Order 2020-32 and 2020-31

WHEREAS, on May 14, 2020 Governor DeSantis issued Executive Order 20-122. initiating Phase 1 of the Safe. Smart. Step-by-Step. Plan for Florida's Recovery to Miami Dade County; and

WHEREAS, on May 18, 2020 the City of Doral issued Emergency Order 2020- 18 moving forward with Phase 1 of the reopening plan and implementing the County's reopening strategy; and

WHEREAS, on June 7, 2020 Miami Dade County issued Amendment No. 3 that provides clarification on dog parks and allows for tennis competitive doubles; and

**WHEREAS**, The County has outlined guidance for each business to follow. The goal is a safer environment for workers and customers; and

WHEREAS, the guidance contained in the New Normal Guide was developed in close consultation with medical and industry experts and establishes stringent capacity and safety rules that must be followed; and

WHEREAS, the City recognizes the impact of economic hardship, but the risk of COVID-19 infection is still real for all Floridians. Therefore, each business should review the guidance that is relevant to their workplace, prepare a plan based on the guidance for their industry, and put it into action; and



**WHEREAS**, the City Charter grants to the Mayor in a State of Emergency the authority to take actions as may be necessary to protect the lives and health of the residents of the citizens of Doral.

**THEREFORE**, under the of Section 1.04 of the City Charter, and the home rule powers permitted under the Constitution and laws of the State, the City of Doral will open and implement the County's reopening plan.

<u>Emergency</u>. The Declaration of the State of local Emergency is extended for seven (7) days if not cancelled before that period of time. Concurrent with this Declaration is the authority to take the actions set forth in those Emergency Orders, for the duration of this Declaration.

<u>Section 2. City of Doral Parks.</u> City of Doral Parks are open as per City of Doral Emergency Order 2020-27. The recreation centers will remain closed until further notice.

- a. Organized or competitive play on courts and fields is prohibited, except singles and doubles tennis and racquetball play may be allowed in conformance with the Moving to A New Normal Handbook.
- b. The Trails & Tails Dog park is open subject to the requirements contained in the New Normal Guide and Miami-Dade County Emergency Orders for Dog Parks. Dogs must remain leashed in all areas of the park.
- c. Bike Racks will be accessible to the public.



Section 3. Summer Camps and Youth Sports. Summer camps and Youth sports will be allowed if conducted in conformance with Miami Dade County's Emergency Order 23-20, as amended, and the Moving to A New Normal Handbook incorporated into that order and adopted by the City.

<u>Section 4.</u> Re-Opening. The City has adopted and will continue to follow the guidance contained in the New Normal Guide for reopening businesses in Doral.

**Section 5**. **Failure to comply.** Failure to comply with this Order shall constitute a misdemeanor subject to fines and imprisonment punishable as provided in F.S. §§ 775.082 and 775.083.

The Emergency measures that have been ordered and promulgated above effective are extended through July 9<sup>th</sup>, 2020.
