AGREEMENT BETWEEN THE CITY OF DORAL, FLORIDA AND PETROLEUM TRADERS CORPORATION

This Agreement ("Agreement") made up this 15th day of April 2019, by and between the City of Doral, Florida, a municipal corporation of the State of Florida ("City") and Petroleum Traders Corporation ("Contractor") having its place of business at 7120 Pointe Inverness Way Fort Wayne, IN 46804-7928, for the provision of fuel for City vehicles.

WHEREAS, Petroleum Traders Corporation has an active agreement with the State of Florida (State Term Contract No. 405-000-10-1), dated July 1, 2014, which was competitively entered into in a manner consistent with Chapter 2 of the City Code; and

WHEREAS, on June 13, 2018 the Mayor and the City Council members adopted Resolution No. 18-111 authorizing the City Manager to enter into an agreement with Petroleum Traders Corporation, for the purchase and delivery of fuels at reduced rates for the City vehicles and equipment, based on the State of Florida fuel contract with Petroleum Traders Corporation, for a period of one (1) year with the option to renew for two (2) one-year periods in an amount not to exceed the departmental budgeted amount.

NOW THEREFORE, in consideration of the mutual covenants set forth in this Agreement, the parties agree as follows:

Section 1. Recitals. The above recitals are true and correct and incorporated herein.

Section 2. Agreement. The City of Doral and Petroleum Traders Corporation, agree on the provision of fuel for City vehicles and equipment, based on the State of Florida Bulk Fuel, Gasoline & Diesel contract, State Term Contract No. 405-000-10-1. This Agreement shall expire on June 30, 2019.

Section 3. All terms and conditions including pricing of the State of Florida Bulk Fuel, Gasoline & Diesel contract, State Term Contract No. 405-000-10-1 are incorporated in this agreement.

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, PURSUANT TO SECTION 2-322 OF THE CITY CODE OF ORDINANCES, AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN AGREEMENT FOR A PERIOD OF ONE (1) YEAR WITH AN OPTION TO RENEW FOR TWO (2) ONE (1) YEAR PERIODS, WITH PETROLEUM TRADERS, CORP., MANSFIELD OIL COMPANY, LLC, FOR THE PROVISION OF FUEL FOR THE CITY'S FLEET AND EQUIPMENT, VIA STATE OF FLORIDA DEPARTMENT OF MANAGEMENT SERVICES AGREEMENT # 405-000-10-1, IN AN AMOUNT NOT TO EXCEED THE DEPARTMENTAL BUDGETED AMOUNTS; AUTHORIZING THE CITY MANAGER TO EXECUTE AGREEMENT AND EXPEND BUDGETED FUNDS IN FURTHERANCE HEREOF; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in an effort to continue to provide fuels for the City of Doral's (the "City") fleet and equipment in a timely and cost efficient manner, and to preserve priority fuel deliveries during emergency situations, City staff finds it in the best interest of the City to utilize the State of Florida, Department of Management Services contract with Petroleum Traders, Corp., Mansfield Oil Company, LLC. in an amount not to exceed departmental budgeted amounts; and

WHEREAS, Section 2-322 of the City Code permits the City to procure good and services via that contracts of other governmental entities provided that such contracts have been reached in a competitive manner; and

WHEREAS, Petroleum Traders, Corp., Mansfield Oil Company, LLC. have existing bulk fuel agreements State of Florida, Department of Management Services, dated July 1, 2016, Contract No. 405-000-10-1 (the "State Fuel Agreements"), which was competitively entered into a manner similar to that set forth in Chapter 2, Article V of the City Code.

WHEREAS, staff respectfully request authorization for the City Manager to negotiate and enter into an agreement for a period of one (1) year with the option to renew for two (2) one (1) year periods with Petroleum Traders, Corp., Mansfield Oil Company, LLC., for the purchase and delivery of fuels at reduced rates in an amount not to exceed departmental budgeted amounts, and to authorize the City Manager to expend said budgeted funds with respect to the agreement herein; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

Section 1. Recitals. The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

<u>Section 2.</u> <u>Approval: Authorization</u>. The City Manager is authorized to negotiate and enter into an agreement for a period of one (1) year with the option to renew for two (2) one (1) year periods with Petroleum Traders, Corp., Mansfield Oil Company, LLC., for the purchase and delivery of fuels at reduced rates, the State Fuel Agreements, in an amount not to exceed departmental budgeted amounts. The City Manager is further authorized the City Manager to expend said budgeted funds with respect to the agreement herein.

<u>Section 3.</u> <u>Implementation.</u> The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and the provisions of this Resolution.

Section 4. Effective Date. This Resolution shall take effect immediately upon adoption.
