

RESOLUTION No. 17-07

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING AN OUTDOOR EVENT PERMIT FOR THE MARY KAY FOUNDATION TO HOST THE “PEACE OF YOUR HEART 5K/FIGHTING DOMESTIC VIOLENCE & ABUSE” EVENT AT DORAL CENTRAL PARK, LOCATED AT 3000 NW 87 AVE ON SATURDAY, FEBRUARY 11, 2017 FROM 7:00AM TO 12:00PM; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the Mary Kay Foundation (“Applicant”) seeks approval from the City of Doral for an Outdoor Event Permit, as per the Application attached hereto as Exhibit “A”, which is incorporated herein and made a part hereof by this reference; and

WHEREAS, staff has recommended that Council approve the Applicant’s proposed Outdoor Event Permit to host “Peace of Your Heart 5K/Fighting Domestic Violence & Abuse” event on Saturday, February 11, 2017 from 7:00am to 12:00pm at Doral Central Park located at 3000 NW 87th Ave, Doral, FL 33172, subject to the conditions specified herein.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

Section 2. Approval. The outdoor event permit for “Peace of Your Heart 5K/Fighting Domestic Violence & Abuse” event is hereby approved subject to the following conditions:

1. Compliance with the comments made by the City of Doral Parks Recreation Department, as specified in Exhibit “B”;
2. Compliance with the comments set forth by the City of Doral Police Department, as specified in Exhibit “C”;
3. Payment of all department costs as specified in Exhibit “D”;

4. Acquisition of all required permits and performance of all necessary inspections prior to event start, as specified by the City of Doral Building Department; and
5. Compliance with any conditions imposed by the Mayor and City Council.

The foregoing exhibits are attached hereto and incorporated herein and made a part hereof by this reference.

Section 3. Implementation. The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.

Section 4. Effective Date. This Resolution shall become effective immediately upon adoption.

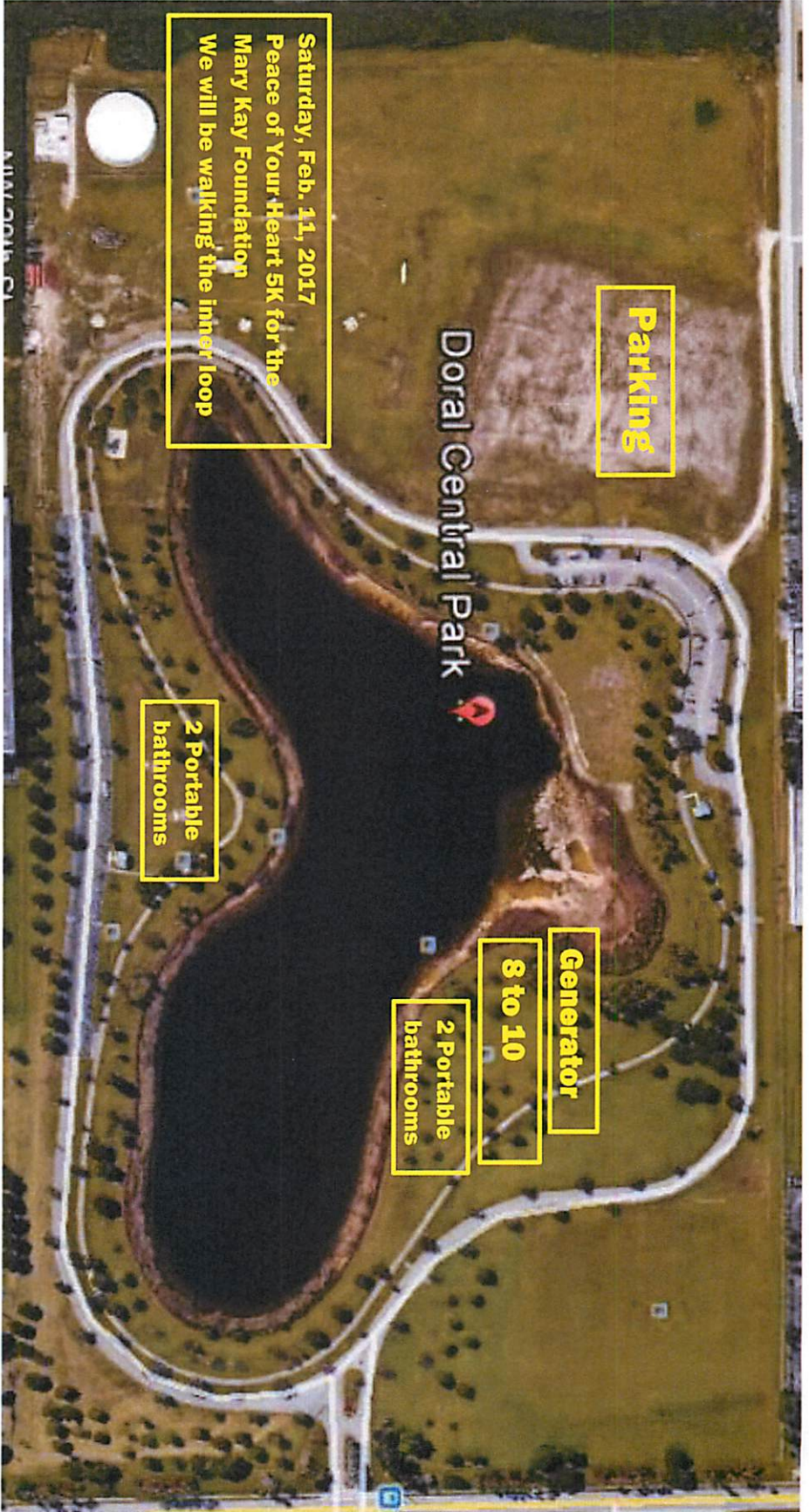



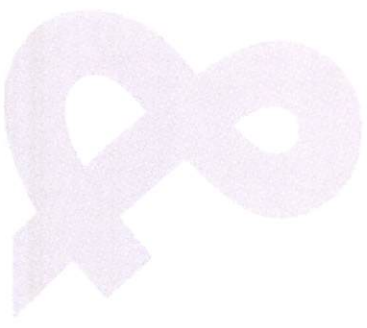

WHY DO PEOPLE STAY IN ABUSIVE RELATIONSHIPS?

One of the most common questions people ask about victims of domestic violence is, "Why don't they just leave?" People stay in abusive relationships for a variety of reasons including:

- The victim fears the abuser's violent behavior will escalate if (s)he tries to leave.
- The abuser has threatened to kill the victim, the victim's family, friends, pets, children and/or himself/herself.
- The victim loves his/her abuser and believes (s)he will change.
- The victim believes abuse is a normal part of a relationship.
- The victim is financially dependent on the abuser.
- The abuser has threatened to take the victim's children away if (s)he leaves.
- The victim wants her/his children to have two parents.
- The victim's religious and/or cultural beliefs preclude him/her from leaving.
- The victim has low self-esteem and believes (s)he is to blame for the abuse.
- The victim is embarrassed to let others know (s)he has been abused.
- The victim has nowhere to go if (s)he leaves.
- The victim fears retribution from the abuser's friends and/or family.

Once again we have started promoting Peace of Your Heart 5K "Peace Begins With You". This is our second annual event to end domestic violence and abuse. Home should be a safe haven. Unfortunately, thousands of homes are like war zones each day because of domestic violence. It has actually become a vicious cycle. We want to stop the violence and break the silence.

The money raised through Peace of Your Heart goes to the Mary Kay Ash Foundation and the Lotus House in Downtown Miami.

The Mary Kay Foundation was founded in 1996. It has awarded \$40 million in grant money to shelters for women and children in all 50 states since its inception. Every October, The Mary Kay Foundation observes National Domestic Violence Awareness Month by awarding grants to deserving women's shelters. In 2014, the Foundation awarded \$20,000 grants to more than 150 women's shelters across the United States for a total of \$3 million.

The Lotus House (founded 2004) in Downtown Miami, houses over 250 women and children on a daily basis, where they are permitted to live free up to a year to give these fragile families the time and tools needed to heal, improve the quality of their lives on every level, achieve greater self-sufficiency, and transition to their new homes. They serve over 450 women and children on an annual basis. They address the special needs of homeless women, youth and children with innovative, holistic, evidence based solutions to break the cycle of childhood abuse, domestic violence and homelessness.

Why We Do It:

Many cases of domestic violence go unreported, so statistics are difficult to get. However, the Family Prevention Fund estimates that between 960,000 and 3 million incidents of family violence go on each year. In 2015, the National Census of Domestic Violence Services reports that more than 71,828 victims were served on the day of September 16, 2015. Domestic violence is the No. 1 cause of injury for women ages 15 to 44. These victims suffer emotionally too from depression, anxiety or social isolation. Domestic abuse occurs to women of all ages, income levels and educational backgrounds. 1 in 4 women experience domestic violence in their lifetime. It's time to change these statistics.

Comments:

- 1) Applicant is to provide a certificate of liability insurance which includes coverage for event participants. Applicant must provide the City with a certificate of liability insurance matching the insurance requirements provided.
- 2) Applicant will be responsible for ensuring that all third party vendors they are using have adequate liability insurance coverage. The organization will ultimately be responsible for any actions or incidents from any third party vendor.
- 3) Applicant must provide parking management.
- 4) Applicant is to obtain proper permits for all applicable amenities.
- 5) Applicant must provide a set-up, timeline, and breakdown schedule for event.
- 6) Organization must identify: Start/Finish line, location of tents, restrooms (if applicable) on the site plan. We recommend the applicant visit the park before submitting revisions.
- 7) Applicant must provide Florida sales tax exemption certificate to waive sales taxes.
- 8) Applicant should confine event amenities into one of the red zones below. For an event of this size tents should remain in one area. We recommend against Zone D, B, and A since the applicant is proposing DJ/live music early in the morning due to the proximity of two (2) hotels.
- 9) All comments and requirements must be addressed by applicant before receiving final approval to host event.
