

**RESOLUTION No.15-160**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING THE AWARD OF THE INVITATION TO BID #2015-19 “MICROSOFT DYNAMICS CRM SERVICES FOR CITY OF DORAL WEBSITE PORTAL, 311, BUSINESS INTELLIGENCE, E-SERVICE REFRESH, PARKS & RECREATION, PUBLIC WORKS AND FACILITIES MANAGEMENT APPLICATIONS” TO AEON NEXUS CORPORATION; AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN AGREEMENT WITH AEON NEXUS CORPORATION, SUBJECT TO APPROVAL AS TO FORM AND LEGAL SUFFICIENCY BY THE CITY ATTORNEY, FOR MICROSOFT DYNAMICS CRM AND WEBSITE PORTAL, E-SERVICE REFRESH AND CONSOLIDATION SERVICES, ALONG WITH IMPLEMENTATION, MAINTENANCE, AND SUPPORT, IN THE TOTAL AMOUNT \$214,540.00 PAYABLE OVER FISCAL YEARS 2014-2015 AND 2015-2016, AND TO EXPEND BUDGETED FUNDS; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, on July 2, 2015, the City of Doral (the “City”) issued Invitation to Bid #2015-19 for “Microsoft Dynamics CRM Services For City Of Doral Website Portal, 311, Business Intelligence, Eservice Refresh, Parks & Recreation, Public Works And Facilities Management Applications” (the “ITB”) for the purchase and installation of certain equipment, for the City’s information technology infrastructure; and

**WHEREAS**, in response to the ITB, one (1) firm attended the mandatory pre-bid meeting held on July 19, 2015 and the City received one (1) submittal by the advertised deadline from Aeon Nexus Corporation (“ANC”); and

**WHEREAS**, ANC was found to be a responsible and responsive bidder; and

**WHEREAS**, staff has recommended the Mayor and City Council authorize the City Manager to enter into agreement with ANC for the purchase and installation of Microsoft Dynamics CRM Platform and Services which includes the City of Doral Website Portal, 311, Business Intelligence, eService Refresh, for Park and Recreation,

Public Works and Facilities Management Applications (the “Services”), in an amount not to exceed \$214,540.00.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

**Section 2. Approval of Award.** The ITB is hereby awarded to ANC, subject to the entering into an agreement with the City on the same or substantially similar terms as presented in ANC’s submittal. The award of the ITB does not in and of itself create or confer a vested contractual right to Techno Systems.

**Section 3. Authorization.** The City Manager is hereby authorized to execute such agreements and other contractual documents, subject to approval by the City Attorney as to form and legal sufficiency, as may be necessary to procure the Services, including implementation, maintenance and support, in a total amount of \$214,540.00, and to expend budgeted funds in furtherance hereof in the following manner: \$63,000.00 from Capital Outlay account-001-22005-500640 in FY 2015, \$125,000.00 from Capital Outlay account-001-22005-500640, for the costs of equipment and implementation of equipment associated with the Services; \$15,000.00 for six (6) months of post implementation from Professional Services Account 001.22005.500310; and \$11,540 for ADX Studio online annual hosting fee from Repairs and Maintenance account 001.22005.500460.

**Section 4. Implementation.** The City Manager and City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.

**Section 5. Effective Date.** This Resolution shall take effect immediately upon adoption.
