A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A WORK ORDER BETWEEN THE CITY OF DORAL AND STRUCTURED CABLING SOLUTIONS, INC., A PREQUALIFIED VENDOR, FOR THE INSTALLATION OF WIRING SERVICES FOR THE LEGACY PARK PROJECT IN AN AMOUNT NOT TO EXCEED \$34,310.74; AUTHORIZING THE CITY MANAGER TO EXECUTE THE WORK ORDER AND EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral (the "City") issued Invitation to Bid #2015-39, "Cabling Services" (the "ITB"), on November 7, 2015 for the purpose of providing data wiring services throughout the City; and

WHEREAS, following competitive bidding and staff recommendation, the City Council approved an agreement with Structured Cabling Solutions ("SCS"); and

WHEREAS, to accomplish requests for service pursuant to the agreement, SCS is to provide individual work orders with detailed scopes and costs, with all work orders exceeding \$15,000.00 submitted to the City Council for approval; and

WHEREAS, the City has a need to install data wiring throughout Doral Legacy Park and staff has recommended that the City Council approve the SCS's work order attached in Exhibit "A", which is incorporated herein and made a part hereof by this reference ("Work Order"), in an amount not to exceed \$34,310.74, and to expend budgeted funds in furtherance thereof.
