

RESOLUTION No. 19-102

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, SELECTING OPTION 3 AS THE PREFERRED ALTERNATIVE CONCEPT FOR STAFF TO PROCEED WITH THE CRITERIA PACKAGE UPDATE FOR THE PEDESTRIAN/BICYCLE BRIDGE OVER DORAL BOULEVARD; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the Public Works Department (PWD) presented conceptual designs to City Council at the June 22, 2016 Zoning Council meeting where the preferred option currently under design was selected; and

WHEREAS, in February 2017, the PWD applied for grant funding through the Florida Department of Transportation (FDOT) Transportation Alternative Program (TAP) Grant; and

WHEREAS, on June 22, 2017 the City was notified we were awarded \$1 million dollars towards the project and the funds were allocated in FDOT's FY 2023; and

WHEREAS, the City requested FDOT to bring the funding forward in order to procure the services of a design-build team and begin construction in FY 2021; and

WHEREAS, at the January 17, 2019 Parks Bond Workshop, City Council made suggestions that would alter the current approved concept; and

WHEREAS, the PWD tasked Pevida Highway Designers to provide conceptual renderings (attached) for Council to select a new preferred option in order to update the criteria package and prepare the project for advertisement.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

Section 1. Recitals. The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

Section 2. Approval. The Mayor and City Council members approve Option 3, in substantially the form attached hereto as Exhibit "A", as the preferred alternative in order to proceed with updating the criteria package and advertising the Request for Proposals.

Section 3. Authorization. The City Manager is hereby authorized to move forward with the preferred option selected by the City Council, subject to approval by the City Attorney as to form and legal sufficiency.

Section 4. Implementation. The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the provisions of this Resolution.

Section 5. Effective Date. This Resolution shall take effect immediately upon adoption.

The foregoing Resolution was offered by Councilmember Cabrera who moved its adoption. The motion was seconded by Vice Mayor Mariaca and upon being put to a vote, the vote was as follows:
