A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING THE INVENTORY LIST OF CITY OWNED PROPERTY APPROPRIATE FOR USE AS AFFORDABLE HOUSING PURSUANT TO SECTION 166.0451, FLORIDA STATUTES; PROVIDING FOR AUTHORIZATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Section 166.0451, Florida Statutes, requires that every three (3) years municipalities in the State of Florida prepare an inventory list of all real property within its jurisdiction to which the municipality holds fee simple title that is appropriate for use as affordable housing; and

WHEREAS, the inventory list must include the address and legal description of the property and specify if the property is vacant or improved; and

WHEREAS, pursuant to said statute, the elected body of the municipality must review the inventory list at a public hearing and make revisions if necessary; and

WHEREAS, the Planning and Zoning Department (the "Department") for the City of Doral (the "City") has reviewed the inventory of City-owned property, and has determined that there is no City-owned property that is appropriate for use as affordable housing; and

WHEREAS, the City Council reviewed the Inventory List prepared by the Department, attached hereto as Exhibit "A," at a duly noticed public hearing held on September 27, 2023, and accepted the same; and

WHEREAS, the City Council finds and declares that adoption of this resolution is in conformance with the requirements of Section 166.0451, Florida Statutes, and is in the public interest of the citizens of the City.

Section 4. Effective Date. The Resolution shall take effect immediately upon adoption.
