On March 3, 2009, The Miami-Dade County Board of County Commissioners approved County Resolution R-178-09. Miami-Dade County/Miami-Dade Transit entered into an Interlocal Agreement with the City of Doral for the provision of public transportation services. This agreement commenced in March 2009 for a period of five years. Thereafter, this agreement is subject to two one-year options to renew, by agreement between the parties.

RESOLUTION No. 08 - 05

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA AUTHORIZING THE CITY MANAGER TO ENTER INTO AN INTERLOCAL AGREEMENT WITH MIAMI-DADE COUNTY TO CONNECT THE DORAL CIRCULATOR WITH MIAMI-DADE COUNTY TRANSIT SERVICES AT NO COST TO THE CITY OF DORAL; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral seeks to improve transportation and reduce traffic congestion on City roadways; and

WHEREAS, the City of Doral offers a regularly scheduled Doral Circulator service to address the immediate needs of public transportation in the City; and

WHEREAS, Staff respectfully requests that Council authorize the City Manager to enter into an interlocal agreement with Miami-Dade County to connect the Doral circulator with Miami-Dade County Transit Services at no cost to the City of Doral.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. The City Council of the City of Doral, Florida hereby authorizes the City Manager to enter into an interlocal agreement with Miami-Dade County to connect the Doral circulator with Miami-Dade County Transit Services at no cost to the City of Doral.

Section 2. This Resolution shall take effect immediately upon adoption.
