RESOLUTION No. 16-175

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, ESTABLISHING AND ADOPTING A TENTATIVE MILLAGE RATE AND LEVY OF AD VALOREM TAXES FOR FISCAL YEAR 2016-2017 IN THE AMOUNT OF 1.9000 MILLS, WHICH IS 7.53% HIGHER THAN THE ROLL-BACK RATE TO BALANCE THE GENERAL FUND FOR FISCAL YEAR 2016-2017; ESTABLISHING THE ROLLED BACK RATE TO BE 1.7669 MILLS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, pursuant to Section 200.065, *Florida Statutes* the City of Doral, Florida (the "City") has established a proposed millage rate; and

WHEREAS, on September 6, 2016, the City Council held a public hearing to consider any adjustment of its proposed millage rate, to adopt a tentative millage rate, and to adopt a tentative operating budget for Fiscal Year 2016-2017 ("FY 2016-2017"), in accordance with Section 200.065(2)(c), *Florida Statutes* and

WHEREAS, on September 27, 2016, the City Council will hold a public hearing to consider any adjustment of its tentative millage rate, to adopt a final millage rate, confirm its rolled-back rate and to adopt a final operating budget for FY 2016-2017, in accordance with Section 200.065(2)(d), *Florida Statutes*; and

WHEREAS, the City Council of the City of Doral establishes, pursuant to State law, a final millage rate to balance the budget for the General Fund for FY 2016-2017.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA:

Section 1. Recitals. The above recitals are true and correct and incorporated herein.

<u>Section 2</u>. <u>Tentative Millage Rate</u>. The City establishes a tentative millage rate of \$1.9000 per \$1,000.00 of assessed property value within the City of Doral, to balance the budget for FY 2016-2017.

<u>Section 3.</u> <u>Rolled-Back Rate</u>. The City further confirms the rolled-back rate for FY 2016-2017 to be 1.7669 mills and the millage rate of 1.9000 mills, which is 7.53% more than the rolled back rate.

Section 4. Effective Date. This Resolution shall become effective upon adoption.
