

Outdoor Event Park Fees

- 1. Applicant is to provide a certificate of liability insurance which includes coverage for event participants. Applicant must provide the City with a certificate of liability insurance matching the insurance requirements provided.
- 2. Applicant will be responsible for ensuring that all third party vendors they are using have adequate liability insurance coverage. The organization will ultimately be responsible for any actions or incidents from any third party vendor.
- 3. Applicant must provide parking management agreement.
- 4. Applicant must provide agreement to utilize parking lots located off-site.
- 5. Applicant is to obtain proper permits for all applicable amenities.
- 6. All dogs must be kept on a leash unless a designated off-leash is created and secured from the rest of the park.
- 7. Dogs are not permitted in the playground.
- 8. The applicant has stated only champagne, prosecco, beers, and alcoholic fruit punches will be served. Alcohol may not be served in glass containers or the original labeled packaging (such as cans or bottles).
- 9. The use of outlets or any other source of power inside the park in prohibited. Organization must provide their own power for the event.
- 10. All tents must be secured using water ballast or concrete buckets. Staking tents within the park is prohibited.
- 11. No vehicles are permitted to drive into the park for set-up. Everything that is to be set-up inside the park is to be brought in by hand-truck or dolly. In the event that the use of a golf cart is approved, the weight placed on the golf cart must be limited as to prevent any damage to the park.
- 12. Any food trucks must utilize off-street parking adjacent to the park. Food trucks are not permitted to be parked inside the park.
- 13. Portable toilets must be stationed in the perimeter of the park, as delivery is typically done with a truck and trucks are not permitted inside the facility.
- 14. Applicant is responsible for ensuring dog owners pick-up after their pets.
