

RESOLUTION NO. 14-23

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA ACCEPTING THE LOW BID AND APPROVING A CONTRACT BETWEEN THE CITY AND WILLIAMS PAVING, INC.; IN AN AMOUNT NOT TO EXCEED \$664,194.09 FOR ROADWAY MILLING, RESURFACING AND STORMWATER IMPROVEMENTS AT NW 117TH AVE., BETWEEN NW 50TH ST. AND NW 58TH ST.; AUTHORIZING THE CITY MANAGER TO EXECUTE THE CONTRACT AND EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in response to Invitation to Bid #2013-31 for “NW 117th Ave. Roadway Milling, Resurfacing and Stormwater Improvements from NW 50th St. to NW 58th St.” (the “Project”), the City of Doral received thirteen (13) bids by the January 10, 2014 deadline with eleven (11) companies meeting the required criteria; and

WHEREAS, upon review of bids received, Staff determined that Williams Paving, Inc. was the lowest most responsive and responsible bidder (the “Contractor”); and

WHEREAS, a copy of Contractor’s Bid Submittal, ITB #2013-31 Inventory, Bid Tabulation, and Contract Agreement are attached as Exhibit A; and

WHEREAS, the City Council finds that accepting the bid and entering into a contract for the Project with the Contractor is in the best interest of the City.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

Section 1. Recitals. The above recitals are true and correct and incorporated herein.

Section 2. Approval. The Contract between the City and Contractor for the Project in an amount not to exceed \$664,194.09 (which includes a 10% contingency

amount for unforeseen conditions) a copy of which is attached hereto as Exhibit "A", together with such non-material changes as may be acceptable to the City Manager and approved as to form and legality by the City Attorney, is hereby approved. The City Manager is authorized to execute the Contract and expend budgeted funds on behalf of the City.


Section 3. **Effective Date.** This Resolution shall take effect immediately upon adoption.




