A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, PURSUANT TO SECTION 2-322 OF THE CITY CODE OF ORDINANCES, APPROVING THE PURCHASE OF 3 VEHICLES IN AN AMOUNT NOT TO EXCEED \$65,734.00 VIA THE AGREEMENT WITH THE STATE OF FLORIDA AND DUVAL FORD; AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN AGREEMENT, SUBJECT TO APPROVAL AS TO FORM AND LEGAL SUFFICIENCY BY THE CITY ATTORNEY, AND TO EXPEND BUDGETED FUNDS IN FURTHERANCE HEREOF; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the Building Department for the City of Doral (the "City") seeks to purchase three (3) vehicles from Duval Ford:

WHEREAS, section 2-322 of the City Code Ordinances (the "Code") provides that the City may enter into bids or contracts entered into by other governmental authorities provided that the governmental authority has followed a competitive bidding procedure leading to the award of the bid or contract in question which is substantially similar to the competitive bidding procedures required by the City; and

WHEREAS, Duval Ford and the State of Florida entered into a contract for the purchase and sale of fleet vehicles, which was competitively procured in a manner similar to that set forth in the City's procurement regulations (the "State Contract"); and

WHEREAS, Staff has recommended that City Council Authorize the City Manager to negotiate and enter into an agreement with Duval Ford for the purchase of 3 vehicles in an amount not to exceed \$65,830 via the State Contract.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL
OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

<u>Section 1</u>. <u>Recitals</u>. The foregoing recitals are confirmed, adopted and incorporated herein and made a part hereof by this reference.

Section 2. Approval. Pursuant to section 2-322 of the City Code, the purchase of 3 vehicles from Duval Ford in an amount not to exceed \$65,734 via the State Contract is hereby approved. This purchase is funded in account 001.7000.524.500641 (Capital Outlay Vehicles).

Section 3. Authorization. The City Manager is hereby authorized to enter into an agreement and other contractual documents, subject to approval as to form and legal sufficiency by the City Attorney, as may be necessary to procure the Vehicles under the State of Florida Contract with Duval Ford, and to expend funds in furtherance thereof, in an amount not to exceed \$65,734.

<u>Section 4.</u> <u>Implementation.</u> The City Manager and City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this resolution.

Section 5. Effective Date. This Resolution shall become effective immediately upon its adoption.
