

**RESOLUTION No. 10 – 67**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA WAIVING THE COMPETITIVE BIDDING PROCESS AND ADOPTING THE TERMS OF THE EXISTING CONTRACT WITH VILLAGE OF KEY BISCAYNE AND ATLANTIC RADIO NETWORK, LLC; AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN AGREEMENT WITH ATLANTIC RADIO NETWORK, LLC FOR THE PROVISION OF A SHORT-RANGE RADIO SYSTEM IN AN AMOUNT NOT TO EXCEED \$48,000.00; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the City of Doral seeks to have access to a short-range radio system in preparation for natural and/or man-made disasters; and

**WHEREAS**, because the City lacks the expertise to build its own system with the related infrastructure, Staff recommends that the City contract out for this system; and

**WHEREAS**, pursuant to Ordinance #2004-03, Staff respectfully requests that the City Council waive the competitive bidding process and adopt the terms of the existing contract with Village of Key Biscayne and Atlantic Radio Network, LLC; and

**WHEREAS**, Staff further requests that the City Council authorize the City Manager to negotiate and enter into an agreement with Atlantic Radio Network, LLC for the provisions of a short-range radio system in an amount not to exceed \$48,000.00.

**NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:**

**Section 1.** The City Council of the City of Doral hereby waives the competitive bidding process and adopts the terms of the existing contract with Village of Key Biscayne and Atlantic Radio Network.

**Section 2.** The City Council further authorizes the City Manager to negotiate and enter into an agreement with Atlantic Radio Network, LLC for the provision of a short-range radio system in an amount not to exceed \$48,000.00.

**Section 3.** This Resolution shall take effect immediately upon adoption.

The foregoing resolution was offered by Councilwoman Ruiz who moved its adoption. The motion was seconded by Mayor Bermudez and upon being put to a vote, the vote was as follows:
