WHEREAS, Manolo Vales is a World-Renowned Spanish Artist who works in painting, sculpture and mixed media; and

WHEREAS, His work is forceful and decorated with historical art symbols and he has received various awards; and

WHEREAS, the Doral Contemporary Art Museum (DORCAM), a non-profit corporation located in the City of Doral partnered with Manolo Valdes to exhibit the artwork at parks within the City beginning December 1, 2020 until June 30, 2021; and

WHEREAS, the art pieces are currently in the possession of ASU Bronze to transport and install the art at City parks; and

WHEREAS, the Doral Contemporary Art Museum (DORCAM), further desires to retain ASU Bronze to provide maintenance services to the Art pieces during the exhibition and to remove the artwork at the end of the exhibition; and

WHEREAS, Funds for the exhibition and insurance of artwork will be allocated from General Government account number 001.50005.500492 and the funds shall not exceed \$145,000.00 in Fiscal Year 2020-2021.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:
