As requested by the City of Doral, Marlin Engineering, Inc. (MARLIN) proposes to provide services to collect vehicular traffic volumes and speed counts within designated speed zones segments for schools located within the city limits.

Scope of Services

Task 1 Project Scope Development

A preliminary assessment of existing school zones within the City has been conducted by MARLIN for 18 schools identified by the City. A desktop review of the schools and 32 adjacent roadway segments was made to determine which schools had existing speed zones. The results of the review determined that there are 15 schools with 27 roadway segments that have existing speed zones as listed below:

- 1. NW 27th Street from NW 112th Avenue to NW 109th Avenue (Doral Academy Preparatory School)
- 2. NW 112th Avenue from NW 25th Street to NW 27th Street (Doral Academy Preparatory School)

Task 2 Data Collection Field Deployment

MARLIN will collect the following data at the above listed locations during non-event typical weekday (Tuesday to Thursday) when schools are in session:

- Bi-Directional 72-hour traffic volume counts
- Bi-Directional 72-hour speed data (85th percentile speed)

MARLIN will coordinate with City staff and the schools to confirm the best const cutive days to schedule the counts

Task 3 Data Processing and Documentation

The data will be processed in the office and a quality review will be conducted to identify any issues or abnormalities. Any issues/abnormalities noted with a count location may require re deployment to be conducted under a change work order. The data collection reports will be provided in tabular format in pdf and excel versions for each location. In addition, a summary of the results will be tabulated and shown graphically on a map.

Task 4 Project Administration & Coordination

MARLIN will submit monthly invoices on work completed to date and provide statu 3 updates on the schedule in a timely manner.
