

**RESOLUTION No. 19-16**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, PURSUANT TO SECTION 2-322 OF THE CITY CODE OF ORDINANCES, APPROVING THE PURCHASE OF A 2019 FORD SUPER DUTY F-550 (24 PASSENGER) BUS TO PROMOTE COMMUNITY YOUTH PROGRAMS, IN AN AMOUNT NOT TO EXCEED \$85,312.92 VIA THE AGREEMENT WITH THE STATE OF FLORIDA CONTRACT NO. 25100000-18-1 WITH GARBER FORD; AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN AGREEMENT, SUBJECT TO APPROVAL AS TO FORM AND LEGAL SUFFICIENCY BY THE CITY ATTORNEY FOR THE PURCHASE; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the Police Department for the City of Doral (the "City") seeks to purchase a 2019 Ford Super Duty F-550 (24 passenger) bus from Garber Ford, State of Florida Contract #25100000-18-1; and

**WHEREAS**, to reward our youth involved in our Community Programs, which we often take them on educational field trips and to many Community Service events; and

**WHEREAS**, Staff respectfully requests that the City Council authorize the City Manager to negotiate and enter into an agreement with Garber Ford for the purchase of a 2019 Ford Super Duty F-550 (24 passenger) bus to promote Community Youth Programs, in an amount not to exceed \$85,312.92 via Garber Ford and the State of Florida Contract which was competitively entered into in a manner similar to that set forth in Chapter 2, Article V of the City Code;

**NOW, THEREFORE BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are confirmed, adopted, and

incorporated herein and made part hereof by this reference.

**Section 2. Approval.** Pursuant to section 2-322 of the City Code of Ordinances, the purchase of a 2019 Ford Super Duty F-550 (24 passenger) bus to promote Community Youth Programs, in an amount not to exceed \$85,312.92 via the State of Florida Agreement with Garber Ford. This purchase is funded in account 001.60005.500641- Capital Outlay- Vehicles.

**Section 3. Authorization.** The City Manager is hereby authorized to enter into an agreement and other contractual documents, subject to approval as to form and legal sufficiency by the City Attorney, as may be necessary to procure the Vehicles under the State of Florida contract with Garber Ford, and to expend funds in furtherance thereof in amounts not to exceed \$85,312.92.

**Section 4. Implementation.** The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and the provisions of this Resolution.

**Section 5. Effective Date.** This Resolution shall take effect immediately upon adoption.
