The City of Doral authorizes the firm of ADA Engineering to proceed with design of stormwater improvements for Sub Basin A-4, a portion of Year 5 of the 5-Year Capital Improvement Plan Proposed on the 2013 Stormwater Master Plan Update as of the date of this Work Order. The work should be performed in accordance with the contract provisions contained in the Continuing Professional Services Final Agreement between ADA Engineering and the City of Doral dated February 2, 2015, and the attached Proposal submitted by ADA Engineering for the above referenced project.

**SCOPE OF SERVICES AND SCHEDULE:**

The scope of the project will be as described in the attached proposal from ADA Engineering dated May 23, 2017, to provide professional engineering service which include: surveying, geotechnical testing, design, cost estimate, and permitting for Sub Basin A-4 of the Stormwater Master Plan adopted in March 2014. The Schedule requires the work to be performed within two hundred and ten (210) calendar days from the notice to proceed. The performance of services associated with this Work Order will be executed on a time and material basis with a not to exceed amount of \$143,944.16.

You are required by the Continuing Service Agreement to begin work subsequent to the execution of this Work Order, or as directed otherwise. If you fail to begin work subsequent to the execution of this Work Order, the City of Doral will be entitled to disqualify the Proposal, and revoke the award.

This Work Order incorporates the terms and conditions set forth in the Continuing Services Agreement dated February 2, 2015 between the parties as though fully set forth herein. In the event that any terms or conditions of this Work Order conflict with the Continuing Services Agreement, the provisions of this specific Work Order shall prevail and apply. Work Order is not binding until the City of Doral agrees and approves this Work Order.


IN WITNESS WHEREOF, the parties hereto have executed this Agreement on the day and date first above written, in three (3) counterparts, each of which shall, without proof or accounting for the other counterpart be deemed an original Contract.



**RESOLUTION No. 17-113**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A WORK ORDER BETWEEN THE CITY OF DORAL AND ADA ENGINEERING, FOR THE PROVISION OF STORMWATER IMPROVEMENTS DESIGN AND PERMITTING SERVICES FOR SUB BASIN A-4, A PORTION OF YEAR 5 OF THE STORMWATER MASTER PLAN CAPITAL IMPROVEMENT PLAN IN AN AMOUNT NOT TO EXCEED \$143,944.16; RECOGNIZING THAT ADA ENGINEERING IS A CITY OF DORAL PRE-QUALIFIED VENDOR; AUTHORIZING THE CITY MANAGER TO EXECUTE THE WORK ORDER AND EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY IN FURTHERANCE HEREOF; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, On March 12, 2014, the 2013 Stormwater Master Plan and the proposed 5-Year Capital Improvement Plan was adopted by City Council for the City of Doral (the "City") via Resolution No. 14-52; and

**WHEREAS**, the City Public Works Department ("PWD") wishes to secure a firm to provide design and permitting services for stormwater improvements at Sub Basin A-4 of the Stormwater Master Plan; and

**WHEREAS**, ADA Engineering is a pre-qualified provider of professional engineering services selected in accordance with Consultant Competitive Negotiation Act requirements and approved by the City Council in December 2014; and

**WHEREAS**, City staff has recommended that the City Council approve Work Order No. 11 for ADA Engineering, a copy of which is attached hereto as Exhibit "A", for the provision of design and permitting services for stormwater improvements at Sub Basin A-4 in a not to exceed amount of \$143,944.16; and

**WHEREAS**, staff has further recommended that the City Council authorizes the City Manager to execute Work Order No. 11, and to expend budgeted funds in furtherance hereof.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF  
THE CITY OF DORAL, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

**Section 2. Approval.** Work Order No. 11 for design and permitting services of stormwater improvements at Sub Basin A-4 of the Stormwater Master Plan in an amount not to exceed \$143,944.16, a copy of which is attached hereto as Exhibit "A", which is incorporated herein and made a part hereof by this reference, together with such non-material changes as may be acceptable to the City Manager and approved as to form and legality by the City Attorney, is hereby approved.

**Section 3. Authorization.** The City Manager is authorized to execute the Work Order and expend budgeted funds on behalf of the City in furtherance hereof.

**Section 4. Implementation.** The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and the provisions of this Resolution.

**Section 5. Effective Date.** This Resolution shall take effect immediately upon adoption.
