

RESOLUTION No. 20-227

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, PURSUANT TO SECTION 2-322 OF THE CITY'S CODE OF ORDINANCES, AUTHORIZING THE CITY MANAGER TO ADOPT THE EXISTING FLORIDA STATE DEPARTMENT OF MANAGEMENT SERVICES CONTRACT No. 56120000-19-ACS, WHICH WAS COMPETITIVELY ENTERED INTO IN A MANNER SIMILAR TO THAT SET FORTH IN CHAPTER 2, ARTICLE V OF THE CITY'S CODE; AND TO ENTER INTO AN AGREEMENT WITH THE PREQUALIFIED POOL OF VENDORS AND/OR AUTHORIZED DISTRIBUTORS FOR THE PURCHASE OF OFFICE FURNITURE IN AN AMOUNT NOT TO EXCEED ANNUAL BUDGETED FUNDS; AUTHORIZING THE CITY MANAGER TO ADOPT THE EXISTING FLORIDA STATE CONTRACT AND TO EXPEND BUDGETED FUNDS IN FURTHERANCE HEREOF; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, as the City continues to grow, there is a need for the City's facilities to adapt and transform in order to address the needs of a growing staff and ensure that the best possible service is provided to the community; the topics of upgrading systems and improving operating practices have been a top priority; and

WHEREAS, on September 11, 2019 the Mayor and the City Councilmembers adopted Resolution 19-230 (approved 4-0, 1 Absent), authorizing the adoption of the Florida State – Department of Management Services, Contract No. 425-001-12-1, that expired on September 1, 2020, for purchase of office furniture citywide; and

WHEREAS, in an effort to continue to provide the highest quality service possible, in a timely and cost-efficient manner, the Public Works Department (PWD) recommends the adoption of the Florida State – Department of Management Services, Contract No. 56120000-19-ACS; and

WHEREAS, this adoption will allow the City to continue to purchase any necessary furniture at a favorable rate; and

WHEREAS, the PWD respectfully requests that the Mayor and the City Council-Members authorize the City Manager to adopt the Florida State – Department of Management Services, Contract No. 56120000-19-ACS, for the term of the contract and any necessary extension periods for the purchase of office furniture for City Facilities on an as needed basis in an amount not to exceed annual budgeted funds; and

WHEREAS, this contract may be used by all City Departments.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

Section 1. Recitals. The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

Section 2. Approval. The Mayor and the City Council of the City of Doral hereby authorizes the City Manager to adopt the existing Florida State – Department of Management Services, Contract No. 56120000-19-ACS, and enter into agreements with the approved manufacturers, manufacturer’s representatives, and any additional manufacturer that may be added to the pool for the term of the contract and any extension periods for the provision of office furniture acquisition, in an amount not to exceed annual budgeted funds, is hereby approved.

Section 3. Authorization. The City Manager is authorized to execute the Adoption of the Florida State Contract No. 56120000-19-ACS and expend budgeted funds on behalf of the City in furtherance hereof.

Section 4. Implementation. The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and the provisions of this Resolution.

Section 5. Effective Date. This Resolution shall take effect immediately upon adoption.

The foregoing Resolution was offered by Councilmember Mariaca who moved its adoption.
