A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO ENTER INTO AN AGREEMENT WITH DORAL LINCOLN MERCURY, LLC TO PROVIDE NON-WARRANTY VEHICLE REPAIRS AND MAINTENANCE TO THE POLICE DEPARTMENT'S FLEET; AUTHORIZING THE INCREASE OF PURCHASE ORDER 20140319 BY \$55,000.00 IN A TOTAL AMOUNT NOT TO EXCEED \$100,000.00; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the age of the Police Department's fleet is directly impacting the budget as the vehicles are no longer under warranty; and

WHEREAS, in response to the need for repairs and maintenance to the fleet, the City advertised RFP #2013-27, entitled "Non-Warranty Vehicle Maintenance and Repair"; and

WHEREAS, the City awarded a contract to Doral Lincoln Mercury as the primary vendor of choice to perform the necessary services; and

WHEREAS, in order to cover the costs of the repair and maintenance of the Police Department's non-warranty vehicles, the existing Purchase Order 20140319 must be increased by \$55,000.00 in a total amount not to exceed \$100,000.00;

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL
OF THE CITY OF DORAL AS FOLLOWS:

<u>Section 1.</u> The appropriate City officials are hereby authorized to enter into an agreement with Doral Lincoln Mercury, LLC to provide non-warranty vehicle repairs and maintenance to the Police Department's non-warranty vehicles..

<u>Section 2.</u> The appropriate City officials are hereby authorized to increase Purchase Order 20140319 by \$55,000.00 in a total amount not to exceed \$100,000.00,

in order to cover the costs of the repair and maintenance of the Police Department's non-warranty vehicles.

Section 3. This Resolution shall become effective immediately upon its adoption.
