

RESOLUTION No. 13-91

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA APPROVING THE RANKINGS OF THE SUBMITTED PROPOSALS IN RESPONSE TO RFQ #2013-16 TITLED "HOLIDAY PARK LIGHTING," AUTHORIZING THE CITY MANAGER AND THE CITY ATTORNEY TO NEGOTIATE AND ENTER INTO AN AGREEMENT WITH THE TOP-RANKED FIRM, GREENSLEEVES, INC., FOR THE PROVISION AND INSTALLATION OF HOLIDAY LIGHTING AND DECOR AT DORAL GOVERNMENT CENTER AND DOWNTOWN DORAL PARK FOR A PERIOD OF ONE (1) YEAR WITH THE OPTION OF TWO (2) ADDITIONAL ONE (1) YEAR RENEWALS PER FISCAL YEAR AND AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN AGREEMENT WITH THE SECOND MOST RESPONSIVE AND RESPONSIBLE PROPOSER, BRANDANO DISPLAYS, INC., IF AN AGREEMENT CANNOT BE REACHED WITH GREENSLEEVES, INC.; AUTHORIZING THE CITY MANAGER TO EXECUTE THE AGREEMENT AND EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY WITH RESPECT TO THE AGREEMENT APPROVED HEREIN; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in response to RFQ #2013-16 titled "Holiday Park Lighting," the City of Doral received three (3) responses by the July 23rd, 2013, 11:00 a.m. deadline; and

WHEREAS, upon a review of the proposals, the selection committee ranked Greensleeves, Inc., as the most qualified and responsible proposer scoring 97.67 out of a possible 100 points; and

WHEREAS, Staff respectfully requests that the City Council approve the selection committee's ranking of the submitted proposals in response to RFQ #2013-16, and authorize the City Manager to negotiate and enter into an agreement with Greensleeves, Inc., for the provision and installation of holiday lighting and decor for a period of one (1) year with the option of two (2) additional one (1) year renewals; and

WHEREAS, if the City Manager cannot successfully negotiate an agreement with

Greensleeves, Inc., the City Council authorizes the City Manager to negotiate and enter into an agreement with Brandano Displays, Inc., the second ranked proposer.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are true and correct and incorporated herein.

Section 2. Rankings. The City Council hereby approves the selection committee's ranking of the submitted proposals in response to RFQ #2013-16 titled "Holiday Park Lighting,"


Section 3. Authorization. The City Council authorizes the City Manager and the City Attorney to negotiate and enter into an agreement with Greensleeves, Inc., as the top-ranked firm, for the for the provision and installation of holiday lighting and decor for a period of one (1) year with the option of two (2) additional one (1) year renewals, and authorizes the City Manager to expend budgeted funds on behalf of the City with respect to the agreement approved herein. The City Council hereby authorizes the City Manager to negotiate and enter into an agreement with Brandano Displays, Inc., if an agreement cannot be reached with Greensleeves, Inc.

Section 4. Effective Date. This Resolution shall take effect immediately upon adoption.

The foregoing resolution was offered by Councilmember Ruiz who moved its adoption. The motion was seconded by Councilmember Rodriguez and upon being put to a vote, the vote was as follows:


