

RESOLUTION No. 19-73

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING AN OUTDOOR EVENT PERMIT FOR CORAZONES POR LA VIDA FOUNDATION TO HOST “LUNA LIBERTAD 2019” AT DORAL CENTRAL PARK LOCATED AT 3000 NW 87 AVE, DORAL, FL 33172, TO OPERATE ON OR AFTER SATURDAY MAY 25, 2019 FROM 5:00PM TO 11:00PM; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the Corazones Por La Vida Foundation (“Applicant”) seeks approval from the City of Doral for an Outdoor Event Permit; and

WHEREAS, staff recommends Council to approve the proposed Outdoor Event Permit to host the “Luna Libertad 2019” event on or after Saturday May 25, 2019 from 5:00pm to 11:00pm, located at Doral Central Park, 3000 NW 87th Ave, Doral, FL 33172.

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are true and correct and incorporated herein.

Section 2. Approval. The outdoor event permit for the “Luna Libertad 2019” is hereby approved subject to the following conditions:

1. Applicant shall comply with the comments made by the City of Doral Police Department.
2. All building permits and inspections required by the Building Department shall be completed prior to the event start date.
3. Applicant shall provide a current certificate of insurance prior to the event start date.
4. Applicant is responsible to pay all outstanding city fees prior to the issuance of the Outdoor Events Permit.

Section 3. Effective Date. This Resolution shall take effect immediately upon adoption.

The foregoing Resolution was offered by Councilmember Fraga who moved its adoption.
