

**RESOLUTION No. 10 – 51**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA ADOPTING THE COMPETITIVELY BID TERMS OF THE AGREEMENT BETWEEN ALL FLORIDA TREE AND LANDSCAPE, INC. AND THE CITY OF FT. LAUDERDALE, FL FOR THE PROVISION OF SITE CLEARING IN AN AMOUNT NOT TO EXCEED \$75,000.00; DIRECTING THE CITY MANAGER AND THE CITY ATTORNEY TO NEGOTIATE AND ENTER INTO AN AGREEMENT WITH ALL FLORIDA TREE AND LANDSCAPE, INC. ON THE BASIS OF SAID TERMS; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the City of Doral requires site cleaning services to clear the vegetation from the proposed Police Headquarters Facility; and

**WHEREAS**, in May 2008, the City of Ft. Lauderdale, Florida awarded a contract for site clearing to All Florida Tree & Landscape, Inc. (All Florida) following a competitive bidding process; and

**WHEREAS**, pursuant to Section 12-10 of the City of Doral Ordinance #2004-03 titled "Purchasing and Procurement," Staff respectfully requests that the City Council adopt the competitively bid terms of the agreement between All Florida and the City of Ft. Lauderdale, FL for the provision of site clearing in an amount not to exceed \$75,000.00; and

**WHEREAS**, Staff further requests that the City Council authorize the City Manager and the City Attorney to negotiate and enter into an agreement with All Florida on the basis of said terms.

**NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:**

**Section 1.** The City Council of the City of Doral hereby adopts the competitively bid terms of the agreement between All Florida and the City of Ft. Lauderdale, FL for the provision of site clearing in an amount not to exceed \$75,000.00.

**Section 2.** The City Council of the City of Doral further directs the City Manager and the City Attorney to negotiate and enter into an agreement with All Florida on the basis of said terms

**Section 3.** This Resolution shall take effect immediately upon adoption.
