

RESOLUTION No. 19-10

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE CITY MANAGER TO ENTER INTO A JOINT USE AGREEMENT WITH DIVINE SAVIOR ACADEMY TO MAKE AVAILABLE OUTDOOR AND INDOOR RECREATIONAL FACILITIES FOR THE USE AND BENEFIT OF THE CITY OF DORAL AND THE STUDENTS OF DIVINE SAVIOR ACADEMY, FOR AN INITIAL PERIOD OF THREE (3) YEARS WITH THE OPTION TO RENEW THE AGREEMENT FOR TEN (10) ADDITIONAL ONE (1) YEAR PERIODS; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, The City of Doral seeks to maximize its recreational space and involvement with the community; and

WHEREAS, the existing Joint Use Agreement has allowed the City and the school access to more space and resources while also creating a positive working relationship; and

WHEREAS, Staff respectfully requests that the City Council authorize the City Manager to enter into a Joint Use Agreement with Divine Savior Academy to make available outdoor and indoor recreational facilities for the use and benefit of the students of Divine Savior Academy and the residents of the City of Doral for an initial period of three (3) years with the option to renew the agreement for ten (10) additional one (1) year periods; and

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

Section 2. Approval & Authorization. The City Council hereby authorizes the City Manager to enter into a Joint Use Agreement with Divine Savior Academy to make available outdoor and indoor recreational facilities for the use and benefit of the students of

Divine Savior Academy and the residents of the City of Doral for an initial period of three (3) years with the option to renew the agreement for an additional ten (10) one (1) year renewals.

Section 3. Implementation. The City Manager and the City Attorney are hereby authorized to take such action as may be necessary to implement the provisions of this Resolution.

Section 4. Effective Date. This resolution shall take effect immediately upon adoption.

The foregoing Resolution was offered by Vice Mayor Mariaca who moved its adoption.
