In the event that any terms or conditions of this Work Order conflict with the Continuing Services Agreement, the provisions of this specific Work Order shall prevail and apply.

Work Order is not binding until the City of Doral agrees and approves this Work Order.

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A WORK ORDER BETWEEN THE CITY OF DORAL AND GANNETT FLEMING, INC. FOR THE PROVISION OF CONSTRUCTION ENGINEERING INSPECTION (CEI) SERVICES FOR THE CONSTRUCTION OF THE ROADWAY WIDENING ALONG NW 82 AVENUE BETWEEN NW 27 STREET AND NW 33 STREET, IN AN AMOUNT NOT TO EXCEED \$200,000.00; RECOGNIZING THAT GANNETT FLEMING, INC. IS A CITY OF DORAL PRE-QUALIFIED VENDOR; AUTHORIZING THE CITY MANAGER TO EXECUTE THE WORK ORDER AND EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral Public Works Department (PWD) wishes to secure a firm to provide Construction Engineering Inspection (CEI) services for the roadway widening construction along NW 82 Avenue between NW 27 Street and NW 74 Street; and

WHEREAS, Gannett Fleming, Inc. (GF) developed the design plans and obtained all necessary permits and approvals for the project to move forward into construction; and

WHEREAS, GF is a pre-qualified provider of professional engineering services selected in accordance with Consultant Competitive Negotiation Act (CCNA) requirements and approved by the City Council in November 2017; and

WHEREAS, City staff respectfully requests that the City Council approve Work Order No. 3 for GF, a copy of which is attached hereto as Exhibit "A", for the provision of CEI services for the roadway widening construction along NW 82 Avenue between NW 27 Street and NW 33 Street in an amount not to exceed \$200,000.00.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

<u>Section 1. Recitals</u>. The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

<u>Section 5.</u> <u>Effective Date.</u> This Resolution shall take effect immediately upon adoption.
