

RESOLUTION NO. 13-103

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA ACCEPTING THE LOWEST RESPONSIVE AND RESPONSIBLE BID SUBMITTED BY HARRISON UNIFORMS FOR THE PURCHASE OF ONE HUNDRED AND TEN (110) PROTECH MODEL #774P TACTICAL BALLISTIC HELMETS WITH MILITARY SUSPENSION AND PAULSON MODEL #DX6-X.250AFS FACE SHIELDS IN AN AMOUNT NOT TO EXCEED \$42,020.00; DIRECTING THE CITY MANAGER AND THE CITY ATTORNEY TO NEGOTIATE AND ENTER INTO AN AGREEMENT WITH HARRISON UNIFORMS ON THE BASIS OF SAID TERMS, AND AUTORIZING THE CITY MANAGER TO EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY; AND PROVIDING FOR AN EFFECTIVE DATE (POLICE)

WHEREAS, the ITB #2013-20 was issued on August 9, 2013 for the purchase of Ballistic Helmets and Face Shields.

WHEREAS, three (3) Bids were received and opened on September 4, 2013, with two (2) companies meeting the required criteria with the lowest bid being submitted by Harrison Uniforms, Inc.; and

WHEREAS, City staff subsequently reviewed and determined the bid submitted by Harrison Uniforms, Inc. was complete, responsive and responsive; and

WHEREAS, the City Council finds that accepting the bid and entering into an agreement with Harrison Uniforms for the purchase of one hundred and ten (110) Protech Model #774P Tactical Ballistic Helmets with military suspension and Paulson Model #DX6-X.250AFS face shields in an amount not to exceed \$42,020.00 is in the best interest of the City.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

Section 1. Recitals. The above recitals are true and correct and incorporated herein.

Section 2. Bid. The bid submitted by Harrison Uniforms for the purchase of one hundred and ten (110) Protech Model #774P Tactical Ballistic Helmets with military

suspension and Paulson Model #DX6-X.250AFS face shields in an amount not to exceed \$42,020.00, is hereby accepted.

Section 3. Authorization. The City Manager and the City Attorney are to negotiate and enter into an agreement with Harrison Uniforms, Inc. based upon the bid accepted herein, and the City Manager is authorized to expend budgeted funds on behalf of the City.

Section 4. Effective Date. This Resolution shall take effect immediately upon adoption.

The foregoing resolution was offered by Councilmember Rodriguez who moved its adoption. The motion was seconded by Vice Mayor Rodriguez Aguilera and upon being put to a vote, the vote was as follows:
