WHEREAS, staff recommends approval to transfer funds allocated for these programs/events under the 001.50005.500450 and 001.50005.500240 account to the Parks and Recreation Department and Public Affairs Division expense accounts in the total amount of \$82,530.00.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:
