

**RESOLUTION No. 19-283**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A SPECIAL EVENT PERMIT REQUESTED BY DORAL CONTEMPORARY ART MUSEUM TO HOST THE “FUTURE VISIONS - DORCAM VIDEO ART FESTIVAL - DORAL’S MIAMI ART WEEK KICK-OFF EVENT VIP RECEPTION AND OUTDOOR VIDEO ART PROJECTION” TO BE HELD AT DORCAM PREMISES, LOCATED AT 5775 NW 84 AVENUE, DORAL, FL 33166 ON SATURDAY, NOVEMBER 30, 2019 FROM 7:00PM-10:00PM; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, Doral Contemporary Art Museum (the “Applicant”) seeks approval from the City of Doral for a Special Event Permit to host the “Future Visions – DORCAM Video Art Festival – Doral’s Miami Art Week Kick-off Event VIP Reception and Outdoor Video Art Projection” in the City of Doral; and

**WHEREAS**, staff recommends that the Mayor & City Council Members approve the proposed Special Event Permit to host the “Future Visions – DORCAM Video Art Festival – Doral’s Miami Art Week Kick-off Event VIP Reception and Outdoor Video Art Projection” on Saturday, November 30<sup>th</sup>, 2019 at the DORCAM premises, located at 5775 NW 84<sup>th</sup> Ave, Doral, FL 33166, from 7:00 PM - 10:00 PM.
