A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING THE FINAL PLAT FOR OUR LADY OF GUADALUPE, LOCATED AT 11411 NORTHWEST 25TH STREET, CITY OF DORAL, FLORIDA; PROVIDING FOR RECORDATION; AND PROVIDING FOR AN EFFECTIVE DATE

Section 2. Approval. The City Council of the City of Doral hereby approves the final plat for Our Lady of Guadalupe, generally located at 11411 Northwest 25TH Street, City of Doral, Florida, subject to the following conditions:

- 1. All PRM's have to be in place prior to the final plat recordation.
- 2. All PCP's and Lot corners have to be in place or bonded prior to the final plat recordation.

Section 3. Recordation. This Resolution shall be recorded in the Public Records of Miami-Dade County, Florida, with the Applicant to pay the costs thereof.

Section 4. Effective Date. This Resolution shall take effect immediately upon adoption.
